1) CALL TO ORDER - HOLLENBECK 11:00 a.m.

The purpose of the meeting was to meet the District 5240 Governor, Ms. Loretta Butts. DG Loretta is well known to our club because she is a member of the Rotary Club of Atascadero.

Hollenbeck noted that Board members Ken Weathers, Tom Zirk and Davina Bergin were absent.

Many of the Rotary Year 2014/15 Team Members were in attendance as noted above.

Hollenbeck distributed a packet of club information to DG Loretta (copy **attached** to these minutes).

2) GENERAL BUSINESS

DG Loretta asked the Board members to discuss their roles with the club. A highlight of topics discussed included:

- J Neil described the planning that is ongoing in the community for a play ground for special needs children. Global Grant or District Grant funding was discussed. DG Loretta suggested engaging the Atascadero Interact students for input. The project is a multiyear project, and could involve the north county clubs. DG Loretta mentioned that the Rotary Club of Newbury Park is doing a similar project.
- M Conrad described the support our club is providing to the Global Grant project sponsored by the Rotary Club of Santos, Brazil, and the District Grant project sponsored by the Rotary Club of Templeton. M Conrad mentioned a desire to see continued support to the Julius Achion's medical facility (Kristine Clinic).
- D Chafin discussed treasurer activities, and that the club's cashflow is positive.
- R McCrory discussed our Tuesday in the Park fundraiser (recently completed) and our Wine Raffle (underway). The Crab Feed was mentioned, and the tentative date of January 10, 2015 (to be confirmed) was discussed. DG Loretta mentioned that many



from the District may be interested in attending our Crab Feed. R McCrory mentioned the upcoming High School Football luncheon (Nov 5th).

- P Parotti discussed the Take the Lead conference, and that it is under new leadership with Rich Johnson and Dutch Nichols. The financial workshops continue within the high school. RYLA was also discussed, with our club sponsoring six students.
- R Johnson discussed the vocational website with videos, and the reduced mentoring program. DG Loretta mentioned that our club's vocational effort is one that other clubs may want to model as it is much more active than most. R Johnson also discussed the Four Way Test scholarship essay. R Amborn is working with the high school to start a Skills USA Competition within the school system.
