I.

The name of this Corporation is: ROTARY CLUB OF ATASCADERO,
CALIFORNIA

II.

A. This Corporation is a non-profit mutual benefit corporation organized under the Non-profit Mutual Benefit Corporation Law. The purpose of this Corporation is to engage in any lawful act or activity for which a Corporation may be organized under such law.

B. The specific purpose of this Corporation is to encourage and foster the ideal of service as a basis of worthy enterprise, and, in particular, to encourage and foster;

1. The development of acquaintance as an opportunity for service;

2. High ethical standards in business and professions; the recognition of the worthiness of all useful occupations; and the dignifying by each Rotarian of his occupation as an opportunity to serve society;

3. The application of the ideal of service by every Rotarian to his personal, business and community life;

4. The advancement of international understanding, and good will, and peace through a world fellowship, of business and professional men united in the ideal of service.

III.

This club shall meet regularly once each week on the day and at the time provided in the bylaws, provided that in an emergency, or for good cause, the Board of Directors of the club may change the regular meeting of any week to any day during

the period commencing with the day following the preceding regular meeting and extending to the day preceding the next regular meeting of the club or to a different hour of the regular day, or to a different place, or cancel the regular meeting of any week when it falls on a legal holiday, or because of the death of the club president or an epidemic or a disaster effecting the entire community.

An annual meeting for the election of officers of this club shall be held not later than the 31st day of December of each year as provided in the bylaws of this club.

IV.

Notwithstanding any of the above statements of purposes and powers, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the specific purposes of this corporation.
