The Business Member will be listed as such on the Club Roster with an individual designated by the Business Member as its representative admitted as an actual member of the Club and of Rotary International.

There are many reasons and opportunities for a business to be involved. They may find they are motivated by the network with other community members, meet and learn from luncheon speakers, work on a project, serve on a committee, serve on the Club board of directors, attend other Rotary Club meetings, attend the District Conference, or the annual Rotary International Convention.

Business Members will be provided promotional support through listing in the various Club publications, such as the weekly newsletter, social media, or Math Field Day program, and the club will highlight the Business Member on the Club website with the Business Member logo and, if desired, a link to the Business Member's website. The Business Member may refer to its Business Member status supporting Indio Rotary in its own advertising or promotional material.
