All requests should be sponsored by at least one Coronado Rotarian.

### **Financial Information**

Please provide a description of how RCCF funds will be spent and funding the program is currently receiving from other foundations and corporation.

### **Evaluation and Recognition**

Please provide a brief description of how your organization will show the positive impact funds from RCCF will have and on your community, constituents, members, etc. RCCF will expect a short report or letter at the end of the program or service on how/if the desired impact was achieved (no more than 1 page).
