- **Cabinet-level agency established in 1991**
- **Consolidated numerous agencies and technical boards**
- **Enabling statutes (Title 3) define authorities and structure**
- **Charges the Department with safeguarding the public while regulating and promoting agriculture**

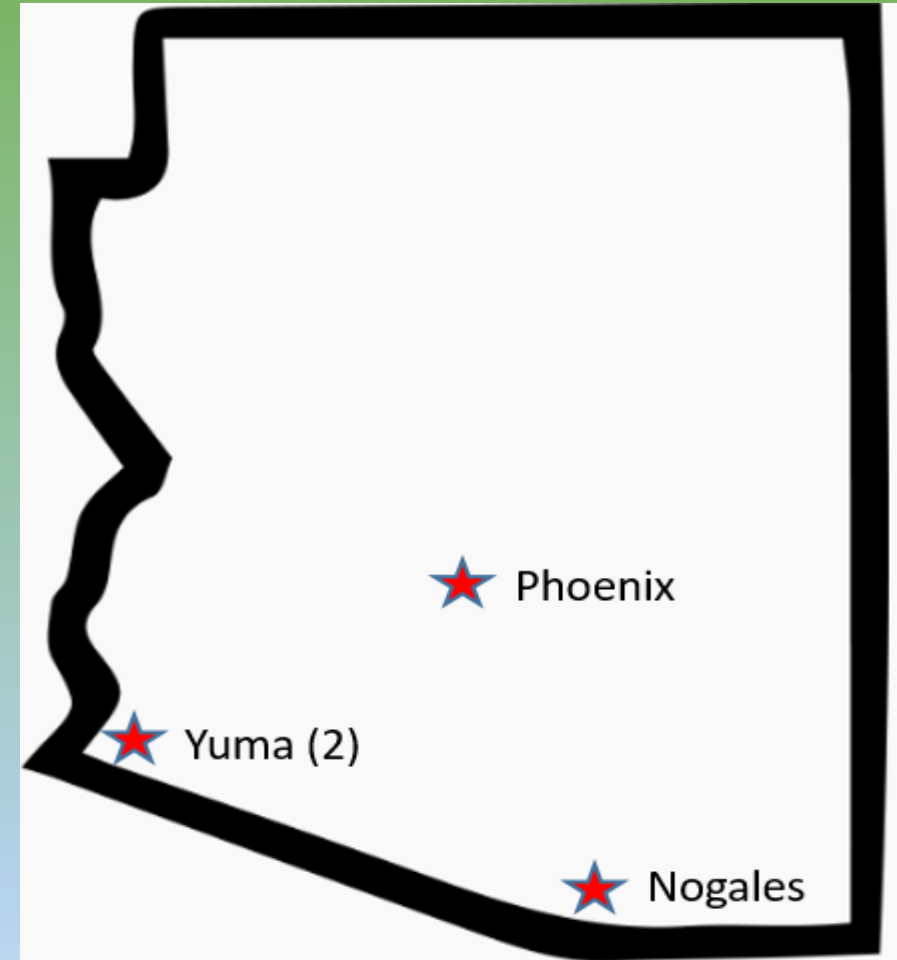

Divisions

Agriculture & Food Support Systems - AFSSD



- Independent of enforcement programs
- Farmers, ranchers, and agribusinesses can seek compliance assistance without the pressure of regulatory consequences
- Foster open communication and collaboration
- Build strong relationships with farmers, agricultural organizations, and local stakeholders to better understand their needs and challenges.
- Administers various grant programs
 - Livestock operator fire & flood assistance
 - Livestock & crop conservation grants
 - Specialty crop block grants
 - Resilient food systems infrastructure

Animals Services - ASD

Protects the public and improves the health, quality and marketability of Arizona animals and animal products by:

- **Identifying, diagnosing and preventing existing and emerging animal diseases.**
- **Enforcing laws concerning the movement, sale, importation, transport and processing of livestock.**
- **Conducting food quality and safety inspections of milk, meat and egg products.**



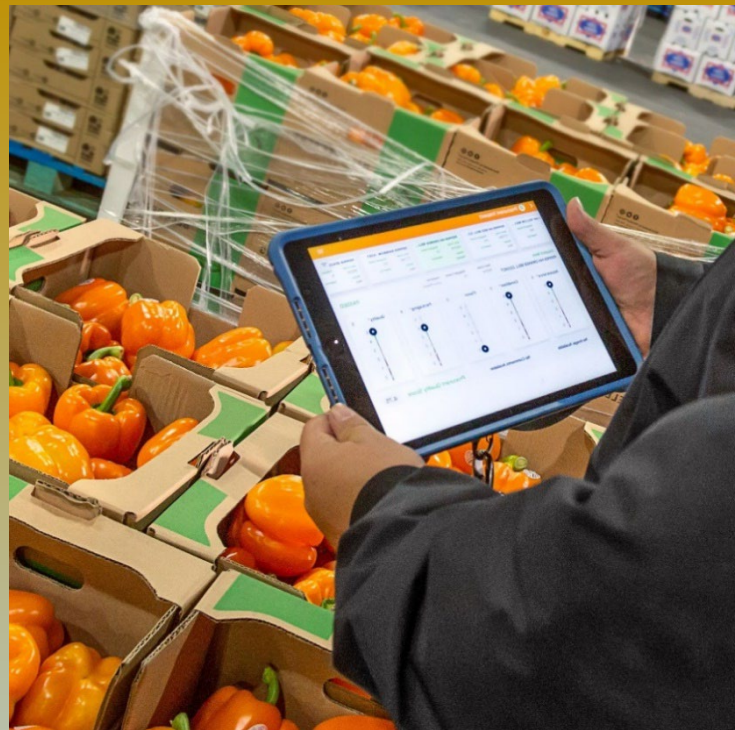

Divisions

Citrus Fruit & Vegetable - CFV

- Provides licensing for produce dealers & shippers
- Collection of statistical data (shippers)
- Conducts quality & grading assurance inspections
- Terminal market inspections
- Complaint response
- Houses the AZ Leafy Green Marketing Agreement program - LGMA
- **Administers the Food Safety Modernization Act – Produce Safety Rule (FSMA-PSR)**





Divisions

Office of the Director



Paul E. Brierley, was raised working on his family's diversified farm. After earning a computer science degree, he returned to production agriculture in southeast Arizona.

He worked with producers across Arizona as **Farm Bureau's Director of Organization for 10 years**. Then, in 2014 became the founding **Executive Director of the University of Arizona's Yuma Center of Excellence for Desert Agriculture**, which he built into a highly effective agricultural research organization.

On June 26, 2023, Paul took over the reins as Director of the Arizona Department of Agriculture under the appointment of Governor Katie Hobbs. Divisions

Environmental Services - ESD

- Ensures ensure adherence to Arizona and Federal regulations involving the production, sales and handling of animal feed, seeds, fertilizer and pesticides
- Enforce regulations that protect employees who handle pesticides or work in areas where pesticides are applied.





Divisions

Pest Management - PMD

- **Regulates 10,000 licensed companies and licensed applicators**
- **Areas of Regulation:**
 - **General Pest Control**
 - **Wood-destroying organism management**
 - **Ornamentals and Turf**
 - **Right of Way**
 - **Aquatic pest management**
 - **Fumigation**





Divisions

Plant Services

- Facilitates commerce and safeguards agriculture
- Establishment and enforcement of external quarantines to prevent introduction of hazardous plant pests.
- Early detection of plant pests to evade establishment and the cost to stakeholders to mitigate.
- Inspection and certification of agricultural and horticultural commodities for domestic and international export.





Divisions

Weights & Measures

Protect the integrity of the marketplace by ensuring that equity and accuracy are preserved in weighing or measuring for commercial purposes.

Basically, we ensure a gallon is a gallon, and a pound is a pound.

Pumps calibrated, scales accurate, proper price posting.

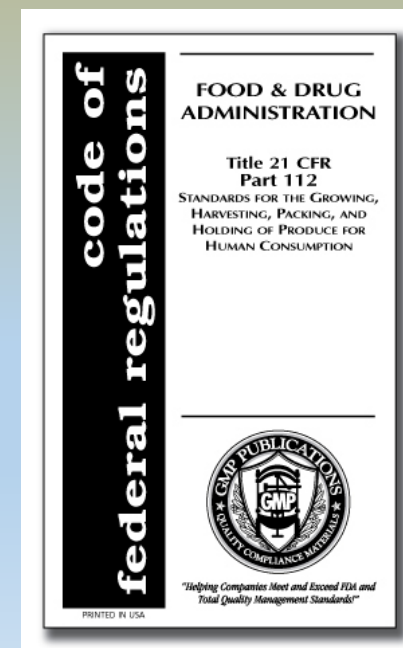
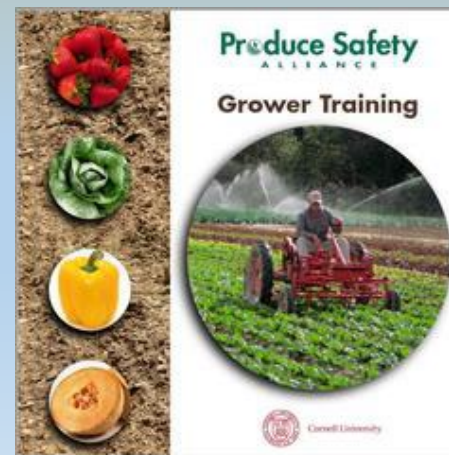

- Regulatory Inspection





Yuma Growing Region

“Winter Salad Bowl Capital”

90% of the leafy greens production

1,000 – 1,200 semi truckloads daily

16 miles long caravan

Start at 1st Ave. & Ina – stretch to the *south* end TIA
