The Prosperity Initiative is a regional partnership working to reduce generational poverty.

- Vision: Every child in every community of Pima County reach adulthood with the skills, tools, and resources for economic stability.
- Goal: Support local individuals to break the cycle of poverty by using evidence-based approaches.
- Result (so far): 13 policies and 3 cross-policy strategies to guide aligned, coordinated investment across Pima County.























Child Poverty Rates Across Pima County

Prosperity Initiative Mandate


Inventorying process:

Aligning Resources & Attracting Investment



Pima County's Outside Agency grant:

• PI goals embedded in application and will be part of the grant award review process.

New Funding for Housing:

The Pima County Board of Supervisors approved:

- \$8.5 million toward affordable housing in next year's fiscal year budget
- Adopted a 10-year policy that <u>allocates at least \$200 million in</u> additional funding for a 10-year period that begins in Fiscal Year 2026-27.
- City of Tucson & Pima County received \$7M Federal PRO HUD Grant for Housing.

Community Coalition for Prosperity

- Secured backbone agency SVP Tucson
 - Steering planning group included Primavera, United Way, SVP, Waters Center, and independent consultants
- Draft committee and structure plan
 - Input from 200+ community leaders/ members
 - Teams: Community Advisory, Implementation, Community Relations, Funders Circle, Leadership Council
- Establishment of Prosperity Initiative-aligned projects
 - Including the City of Tucson's 29th Street Thrive Zone










Local Example

Better Together Coalition - Green Valley & Sahuarita

- **Coalition** of community, government, and business (ex. credit union) leaders
- Identified 4 priority policies: Post-Secondary Education (PSE), Workforce Development/Small Business, Digital Inclusion, Financial Capability
- Supporting the <u>Elevate Ed</u> expansion to Sahuarita Unified SD
 PSE and Workforce priorities
- Planning a Family Financial Fair at a local middle school
 Financial Capability priority






How will we know if we're making progress?
