My family is my second love. My wife, Jan, and I were both widowed in our "middle" years. We feel very fortunate to have found each other, and we recently we celebrated our 20th Wedding Anniversary. Together we have four children and seven grandchildren who reside in California, Indiana, Michigan and Connecticut. We visit each of them several times each year, and between visits we gratefully utilize FaceTime and long phone conversations to keep up on their news.

My new career began as a sales position with a national company selling specialty chemicals to industry and municipalities. It was a good fit, and I was fortunate to advance, eventually managing the company with a national sales force of 275 persons and reporting to the absentee owner.

The travel was overwhelming during these years as I trained managers and visited sales teams across the U.S. Therefore, I decided to utilize my experience to open my own business with a similar business model but only selling to industrial and janitorial distributors in Texas, Oklahoma, Arkansas, Louisiana and Mississippi. My company also manufactured liquid and powdered chemicals. After several years I sold this company.

Through these two enterprises, I realized that I preferred my efforts in sales, training, and employee motivation so I opened a manufacturer's representative agency where these talents would be a utilized. My team focused on representing providers of sanitary supply equipment, products and processes to distributors and volume end-users in a five-state area. I operated this business for 26 years and turned it over to the employees when one of the manufacturers we represented convinced me to become their VP of Sales. After five years of developing markets across the U.S. for microfiber cleaning systems, I retired October 2017.

It was a brief retirement, as by early 2018 I had offers to generate sales for several of my Central Texas distributors, offers to provide training seminars on cleaning products and processes, and an offer to open the Texas market for a company selling PVC decking for decks and docks. I now enjoy flexible, part-time work conducting an occasional seminar and developing the Texas market selling decking. As decking is a new product for me it has become my primary focus.

Without much advance planning, I now have a satisfying "retirement." ST. DAVID'S PARKING GARAGE MESSAGE/INSTRUCTIONS

A message from President Julie about parking: Premier Parking/St. David's garage manager, Angel, will provide 50 parking spaces in the garage every Tuesday for our use. Once those spaces are taken and there are no other parking spaces members should either try to find parking on the surface lot on the church property, which may or may not have spaces available, **OR**...

Drive over to Premier's Trinity surface lot which is on Trinity and 8th, catty-corner to St. David's parking garage. (It's the corner lot that is very steep.) You may also start there, if you'd like. If you park there, go to the kiosk on that lot and punch in the numbers, **1905**. You will <u>not</u> be charged for parking in either the small, surface lot on the church campus nor the Trinity surface parking lot.

Please continue to use your laminated barcode to enter the parking garage and <u>don't punch the button for a paper ticket</u>. Our code is read by the parking system and an accurate count of members will be reported. If you have a guest coming, they *will* take a paper ticket and then they will need to ask the Hospitality Team, when they check in, for a one-time use QR code to exit the garage. If any of your guests park in Premier's Trinity surface lot then they will need to punch in the numbers **1905** at the kiosk, too.

I am deeply sorry for the frustration that many of you have felt, and we all continue to feel, due to the lack of sufficient parking. I'm open to any suggestions for alternative parking arrangements and hope we can focus on our weekly fellowship and continue to positively change our community and the world.

AUSTIN CENTRE—OVERFLOW PARKING REMINDER

As a reminder — we still have an agreement with Austin Centre (the building right across San Jacinto from

the Church...think the Omni, but not - see map image) where they will try to provide overflow parking in their garage on (most) Tuesdays during our weekly lunches!

This garage is MUCH more expensive for us than when you park in St. David's garage, however, since they charge us in 20 minute increments (not a flat rate). So please try to park at St. David's first.

If you park in the Austin Centre garage, you MUST request a validation ticket from one of the Hospitality members when you check in at the meeting! Please note that this is ONLY AVAILABLE for a few hours each Tuesday (you can't park your car there all day for free nor can you park there for free on any other day of the week).

To enter the Austin Centre parking garage, come down 7^{th} Street and turn left onto Brazos. The parking garage entrance is on the right.



If you park there, don't forget to ask the Hospitality Team for a complimentary validation voucher/ticket! YOUR LAMINATED BARCODES WON'T WORK IN THIS GARAGE!
