SETH HOPKINS

Executive Director Booth Western Art Museum

Seth Hopkins is the Executive Director of the Booth Western Art Museum in Cartersville, Georgia, a position he has held since 2000.

Since 2003, he has also served as the Executive Director of Georgia Museums, Inc., which operates the Booth Museum, Bartow History Museum and Tellus – Northwest Georgia Science Museum. Prior to entering the museum profession Hopkins worked in the fields of journalism, public relations, and telecommunications management.

Under his guidance the Booth Museum grew from an initial vision of a 30,000 square regional art center, to a world class, 120,000 square foot Smithson Affiliated museum. The Booth is now the largest permanent exhibition space for Western art in the country. Similarly, Hopkins led the team that transformed the 10,000 square foot Weinman Mineral Museum into the 125,000 square foot Tellus Science Museum, also a Smithsonian Affiliate. *Southwest Art Magazine* included Hopkins on its list of 10 prominent people who are "making noteworthy contributions to the art world."

Hopkins holds an undergraduate degree in journalism from Syracuse University. While in college he participated in the Army ROTC program and was commissioned as a 2nd Lieutenant upon graduation. Hopkins then attended the Infantry Officer Basic Course at Ft. Benning, Georgia and follow on special weapons courses. He has completed courses in art history at Kennesaw State University, Georgia State University and the University of Wyoming, as well as museum studies courses at West Georgia State University.

He received a Master's degree in Museum Studies from the University of Oklahoma in 2005. While at OU he completed his Master's Thesis: *Andy Warhol Played Cowboys and Indians*, under the direction of faculty advisor Byron Price. Among the nearly 100 exhibitions Hopkins has curated or co-curated are *Ansel Adams: Before and After, Blazing the Trail: 50 Years of the Cowboy Artists of America, Selling the Sizzle: The Art of Movie Posters and American Spirit Remembered: The Art of Mort Kuntsler.*

Hopkins twice served as a juror for the annual Arts for the Parks exhibition in Jackson Hole, Wyoming, and has also judged the annual Cowboy Artists of America Show and Sale in Phoenix, Arizona and the Coors Western Art Sale in Denver, Colorado. He has had articles published in *American Art Review, Western Art Collector, and Persimmon Hill*.

In 2010 he was honored with the prestigious Flourish Award, given annually to a leader who has helped the arts flourish in Georgia. He recently served a two year term as President of the Museums West Consortium, a group including the 15 largest and most important Western museums.

Hopkins is a native of Dexter, Maine and currently resides in Cartersville, Georgia with his wife Joyce, son Stephen, step-son Alex, step-daughter Ansley and daughter Hadley.

Our guest speaker, **Rick Timmins**, was introduced by our newest Rotarian **Tarby Bryant**. Mr. Timmins is a good man and Austin resident who wears many business "hats". Besides being a partner at Mid-City Development, Mr. Timmins has personally invested in 44 start-up companies since 2009. He is also a board member with several private, public and non-profit companies.

As a leader and innovator in major companies like Cisco and Motorola, Mr. Timmins brings a great wealth of experience to Mid-City Development, a company that develops commercial and residential properties. All our ears perked up when we were introduced to the concept of "Opportunity Zones" with tax deferral and exemption possibilities.

These Opportunity Zones are designated to encourage investment and development in economically distressed communities. Mid-City Development has constructed many properties in the Austin area, and many of them are designated Opportunity Zones by the Tax Reform Act of late 2017 and early 2018 (go to the U.S. Treasury website to view the designated sites). Mr. Timmins told us that investors can defer/reduce capital gains tax on qualified Opportunity Zone Fund investments.



ST. DAVID'S PARKING GARAGE MESSAGE/INSTRUCTIONS

A message from President Julie about parking: Premier Parking/St. David's garage manager, Angel, will provide 50 parking spaces in the garage every Tuesday for our use. Once those spaces are taken and there are no other parking spaces members should either try to find parking on the surface lot on the church property, which may or may not have spaces available, **OR**...

Drive over to Premier's Trinity surface lot which is on Trinity and 8th, catty-corner to St. David's parking garage. (It's the corner lot that is very steep.) You may also start there, if you'd like. If you park there, go to the kiosk on that lot and punch in the numbers, **1905**. You will <u>not</u> be charged for parking in either the small, surface lot on the church campus nor the Trinity surface parking lot.

Please continue to use your laminated barcode to enter the parking garage and <u>don't punch the button for a paper ticket</u>. Our code is read by the parking system and an accurate count of members will be reported. If you have a guest coming, they *will* take a paper ticket and then they will need to ask the Hospitality Team, when they check in, for a one-time use QR code to exit the garage. If any of your guests park in Premier's Trinity surface lot then they will need to punch in the numbers **1905** at the kiosk, too.

I am deeply sorry for the frustration that many of you have felt, and we all continue to feel, due to the lack of sufficient parking. I'm open to any suggestions for alternative parking arrangements and hope we can focus on our weekly fellowship and continue to positively change our community and the world.

AUSTIN CENTRE—OVERFLOW PARKING REMINDER


As a reminder — we still have an agreement with Austin Centre (the building right across San Jacinto from

the Church...think the Omni, but not — see map image) where they will try to provide overflow parking in their garage on (most) Tuesdays during our weekly lunches!

This garage is MUCH more expensive for us than when you park in St. David's garage, however, since they charge us in 20 minute increments (not a flat rate). So please try to park at St. David's first.

If you park in the Austin Centre garage, you MUST request a validation ticket from one of the Hospitality members when you check in at the meeting! Please note that this is ONLY AVAILABLE for a few hours each Tuesday (you can't park your car there all day for free nor can you park there for free on any other day of the week).

To enter the Austin Centre parking garage, come down 7^{th} Street and turn left onto Brazos. The parking garage entrance is on the right.



If you park there, don't forget to ask the Hospitality Team for a complimentary validation voucher/ticket! YOUR LAMINATED BARCODES WON'T WORK IN THIS GARAGE!
