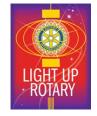

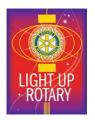

#### **Visioning Report – Danny**

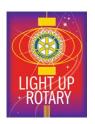
 Danny requested a Club meeting to re-introduce the Club Vision to the members for progress on our future direction.
