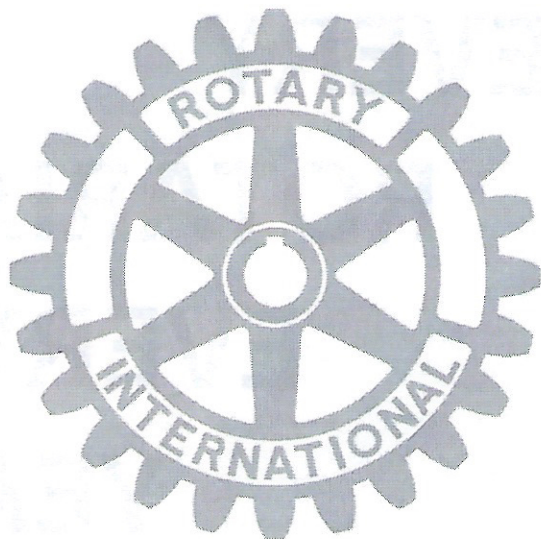
My promise is to not to talk too long and to try very hard to not be boring.
