# Combined Meeting of the Boards of the Portage Rotary Club and Portage Rotary Charities

A combined meeting of the Boards of Directors of the Portage Rotary Club and of Portage Rotary Charities ("Charities") was held on February 24, 2017 at Michelle's Restaurant in Portage, and was called to order at 7:35 AM by President Jim Martin.

**Present:** Board members present were: Christine Berro; John Crandle (3/8); Dave Jewell (3/8); Jim Martin (2/22); Erica McCulley (2/22), Jim Pearson (3/8) and Jeannine Willacker. Absent: Christy Klien; Gary Meyers; Tom Welsh; and Mary Lou Wright. Also present: Chris Buckley (2/8) and Mike Simon (2/8). All dates in parentheses are makeups.

Minutes: Mike Simon, sitting in for Secretary Christy presented the Minutes she had prepared of the meeting of the Boards held on December 16, 2016 which had previously been sent by email to all of the members of the Boards for their comments. After discussion, MMSP that the Minutes be approved as presented.

Secretary's Report: Mike Simon, sitting in for Secretary Christy presented the membership report as of January 31, 2017. At the end of January, 2017, we had 86 members, of whom ten (Paul Ballard,; Joe Hollander; Glen Kellam; Pete Marsiglia; Betty Lee Ongley; Wendell L. Pierce; Allan Reiff; Freeman Russell; Paul Wartner and Joe Yantis) were excused from attendance pursuant to the RI Rule of 85. Currently, four members are on leave of absence (Penny Briscoe, Marlene Camacho Ochoa, Roy Dangel and Larry DeShazor). In January, our attendance was 56.68% and the average of members at each meeting was 44.

Treasurer's Report: Treasurer John presented financial statements of the Club's General Fund and Charities through January, 2017. After discussion thereof, MMSP that the Treasurer's Report be accepted as presented and a copy of it be attached to these Minutes.

Treasurer John reported that the Financial Review Committee had completed its work, and all that remained to be done was its Report to the Boards.

President Jim then called on Jim Pearson for an update on the planning for the facility which will include the Portage Rotary Plaza-Big Idea. Jim informed the Boards that the design of the project had evolved to the point that it had been tentatively decided to raze the current building at the site, and replace it with a pavilion. Further, due to that evolution, the departure of Parks Director Kendall Klingelsmith, and the need to hire his successor, the completion date has been pushed back to late 2017 or 2018.

**President's Report:** President Jim confirmed to the Boards that for personal reasons, Erica McCulley had decided to forego her selection to be the Club's President Nominee Nominee. He further told the Boards that he, with the Nominating Committee, had asked Chris Buckley to assume that role, with it being understood that Chris would succeed Dave Jewell as President. After discussion, **MMSP** that the Boards approve the selection of Chris Buckley to be the Club's President Nominee Nominee. Thereafter, President Jim said that the preceding Motion would be put the Club's membership at the meeting of March 1, 2017 for ratification of the Boards' decision.

President Jim reminded the Boards that nominations were still open for a Club Hero, to be recognized at the upcoming District 6360 Conference.

He next asked Christine Berro about the progress of preparations for our 50<sup>th</sup> Anniversary Gala, she told the Boards of the progress that had been made and her Committee's plans for completing those preparations.

President Jim then reviewed the status of our Visioning Process, saying that member input from our preceding two Club Assemblies had been analyzed and that after our Gala, the Boards would meet to decide on their recommendations for future projects and activities.

**President Elect's Report:** President Elect Dave presented to the Boards with the name of Kendall Klingelsmith as recipient of the Five Avenues of Service Award. Because Kendall was leaving his position on March 3 in preparation for moving to Petoskey, Dave suggested that this award be presented at the Club's March 1 meeting. The boards accepted that suggestion.

President Elect Dave also told the Boards that the remaining three Avenue of Service Award certificates were ready for presentation.

**Grant Chairman's Report:** Because Gary Meyers was absent, the Boards discussed the status of the current grant applications that have been submitted to the Grants Committee.

Other Business: President Jim next asked for a progress report from Christine Berro on the process of recommending a recipient of the Club's Community Service Award. Christine reported that her Committee, after thoroughly discussing a number of excellent nominations, decided to Recommend that the Award be presented to Steve Rodia. After hearing about Mr. Rodia's achievements and public service, and after discussion, MMSP that the 2017 Community Service Award be presented to Steve Rodia.

Correspondence: There was no correspondence requiring the attention of the Boards.

The next meeting of the Boards will be held at 7:30 AM on Friday, March 24, 2017 at Michelle's Restaurant in Portage, MI.

There being no further business to come before the meeting, it was, on Motion, adjourned at 8:25 AM.
