How Does the Power Pack Program Work?

Children are confidentially recommended for a Power Pack by the staff at their school. Parents must sign a permission slip for participation in the program. Parents may also contact Generous Hands to sign their children up for the program.

Power Packs are available at our warehouse each week during posted day and evening distribution hours. Parents may contact GH to arrange for alternate pickup arrangements.

What is a Power Pack?

Power Packs are filled with a variety of kidfriendly nutritious foods and given to children at risk of food insecurity or hunger during the weekends.



Typical Contents of a Power Pack

- ENTREES: Peanut butter, tuna, Easy Mac, canned spaghetti, soup, Ramen noodles
- BREAKFAST FOODS: Cereal, oatmeal, fruit bars
 - FRUIT: Fruit cups or applesauce
- SNACKS: Granola bars, trail mix, microwave popcorn, pretzels, animal crackers

Where Does the Food Come From?

Food for the Power Packs is purchased from Loaves and Fishes, Sam's Club and the South Michigan Food Bank. Food is also donated by local citizens and businesses. Families in the program are offered a weekly voucher redeemable at the Vicksburg Family Fare grocery store. They may purchase bread, eggs, milk, fruit and vegetables, meat and cheese within a specified spending limit.

Generous Hands also provides coupons during the summer months for the Vicksburg Farmer's Market, where families may purchase fruit, vegetables, meat and cheese. These coupons are reimbursed to the vendors of the Farmer's Market.

Volunteers Support

Since Generous Hands is volunteer driven, volunteers are the key to our success! We appreciate all they do.
