This ADDENDUM to the 2021-2022 Williamston Sunrise Rotary Club (WSR) AND Cub Scout Pack263 (CSP 263) of Williamston Michigan "Agreement" will be referred to as "Addendum" in this document. The Annual Charter Agreement between the two clubs will be referred to as "Agreement."

The current Agreement and Addendum will be effective from July 1, 2021 until June 30, 2022.

WSR is an independent non profit, community service organization which is not affiliated with Boy Scouts of America. WSR agrees to serve as CSP 263's host Chartered Organization. As such, WSR agrees that it will not use the affiliation or Scouting brand for any purpose that is not consistent with the goals and objectives of the Scouting program.

In reference to the Agreement, WSR agrees, when appropriate, to include cub scouts in its activities that will accomplish the Scouting goals of youth character development, career mentoring, and community service.

WSR does not engage in partisan political activities.

The Executive Board of WSR has designated James Conroy as its 2021-2022 representative to the local council and to be the primary contact between the organizations. The Executive Board will serve as the support unit and will review and approve any adults chosen to have contact with the Scouting program. The Board will encourage WSR support adults to receive training made available by the Council.

The parties agree that CSP 263 will continue to use its existing adequate facilities to conduct its regular meetings.

WSR conducts an annual state licensed Duck Race Raffle fundraiser to generate funds for Rotary grants for educational scholarships, community improvements, and youth development programs. WSR encourages CSP 263 to participate in all aspects of the Duck Race. However, state law prohibits minors from selling raffle tickets. As such, CSP 263 may participate in the fundraising activities of the Duck Race, only if the Council agrees that any handling of money for the sale of tickets will be conducted by a person over the age of 18. Further, WSR requires that the Council provide written guidance to its members on the appropriate and legal constraints of selling Duck Race tickets on behalf of WSR.

Neither the Agreement nor this Addendum should be interpreted to mean that WSR has agreed to accept any financial responsibility for CSP 263. Further WSR does not agree to assume any liability of, or to indemnify CSP 263 for any of its actions, or actions taken by any third party against CSP 263. By signing this Amendment the parties agree that WSR will be held harmless by CSP 263 and its members for actions taken in good faith and in compliance with the Agreement. And the parties further agree that WSR will be held harmless in any third party claim against CSP 263.
