# MINUTES, BOARD OF DIRECTOR'S MEETING July 31, 2007

The member's present concluded Tom Clay, Jim Seibert, Rick Delaney, Susie Cockerill, Michelle Prinz, Brenda Arnoczky, Bill Penn, Bob Reed, and Matt Maki.

On a motion by Tom that was seconded by Bill the agenda was approved as presented. A copy of the Agenda is attached.

On a motion by Brenda that was seconded by Susie, minutes of prior meetings were approved.

Tom presented the Treasurer's report (copy attached) and it was approved on a motion by Bill that was seconded by Brenda.

Rick asks that the Duck Race Committee do an analysis to determine the member utilization and revenue generated by the members of the club in order to determine the percentage of members utilized and contributing financially.

The Chesaning Rotary Club has contacted us regarding our interest in purchasing some of their ducks. Rick is going to contact them and find out if they are using the same ducks that we use and what their asking price is.

Rick and Bill shared a letter from Tito in which he requested Board approval for a one-year leave of absence. He has found it impossible with the growth and additional responsibilities in his business to continue right now his level of commitment in our club. As a part of this he is stepping down as the fund-raising chair. The Board on a motion by Tom that was seconded by Bill regretfully approved this request. Board members strongly expressed their appreciation for all of the work that Tito has put into this club over its life and sincerely hope that during this year off he will still stop by once in a while and that after the year he will come back and become an active member once again.

Partially as a result of Tito's leave of absence and partially because it is time to do an assessment, the board appointed Matt, Tom, Bill, and Rick to serve as a fund raising evaluation committee with the purpose of making recommendations to the board about future fund-raising for the club. Topics include but are certainly not limited to whether we continue the duck race or not, and the possibility of other fund-raising devices including check writing by club members, poker tournament's, and anything else anyone can think of.

Rick received two letters from potential Eagle Scout's asking for financial support. The Board again reluctantly disapproved contributing funds directly from the club and instead will have the President sent each of these scouts a letter informing them that he will make their needs known

to all club members who may choose to participate individually. The Board believes strongly that it is a slippery slope to begin funding these individual requests and want to limit our financial support to group efforts.

There was much discussion about the planned Founders Day dinner on September 20 including discussion about canceling it and combining it with our Christmas party or perhaps moving it back a couple of weeks to sometime in October. Rick is going to follow up with Carrie Mae and then solicit input from the Board by e-mail regarding final action. Brenda did agree that if the dinner goes forward she is very happy to assist. There was much discussion about who should be invited and it seemed to be the consensus of the board that it should really simply be a smaller members gathering with very small numbers of outsiders who were instrumental in the formation of our club.

Rick led a discussion about the time of board meetings and it was basically agreed that times will vary in the coming year. Some meetings may be held in the evening and some on mornings other than the morning of our club meeting. In particular, it is felt that on those days we have students of the quarter we should not have a board meeting prior to the club meeting.
