MINUTES, BOARD OF DIRECTORS MEETING AUGUST 28, 2007

Members present included Rick Delaney, Tom Clay, Bob Reed, Jim Siebert, Howard Dahlstrom, Sheryl Topliff, Brenda Arnoczky, Bill Penn, Carrie Mae Thorburn, and Michelle Prinz.

The proposed Agenda (copy attached) was approved on a motion by Howard which was seconded by Bob.

Prior Minutes of Board Meetings were approved on a motion by Howard which was seconded by Bill.

Tom presented the Treasurer's report (copy attached). He reported that there is approximately \$15,500 in the bank. He also reported he has had recent problems in dealing with Fifth Third Bank and is considering a change to Independent Bank. Several members of the Board reported that they had seen problems at Independent Bank similar to those Tom experienced with Fifth Third. Carrie Mae also suggested that we might want to consider her firm as a possible option to going with one of the local banks. Tom indicated he would take all of this under advisement before recommending a change. Tom's report was approved by the Board on a motion by Howard which was seconded by Bill.

The Club's 10 year Anniversary party is scheduled to be held at the Brookshire on September 20. Carrie Mae and Brenda are working with Rick in planning this celebration. It has previously been decided to keep this a rather low key, local club members plus a few special guests event. It has been suggested that we might ask Wayne Beasley to serve as an MC for a Roast of sorts. The budget was discussed and the committee was told they could plan on \$1500-\$2000 for this event. It was decided that the club would pick up the cost of the event for members and their spouses and the club's guests.

There was a discussion regarding water projects and in particular about the approximately \$1000 that rests in the Foundation account. Most of those funds came from Howard and Sheryl and they want those funds to go toward the hygiene project in Ecuador. Tom indicated this would be taken care of.

Rick led a discussion about the Sergeant at Arms. Merlin has indicated that he would like to have the flagpole used at our meetings replaced with a purchased pole. There was discussion about the flag but on review the Board decided the flag was in good condition and was one that had flown over the capital and therefore should be retained and used. The Board approved the purchase of any new flagpole and Rick is also going to research proper protocol for displaying the flag during our meetings. It was also discussed that a way to involve new members might be to rotate

the weekly Sergeant at Arms responsibilities. Ultimately it was decided that the President has the prerogative to work through and try different approaches in this area.

It was previously decided that Board meetings that would normally be held on the morning that we have Students of the Quarter should be moved to another time. Rick asked for volunteers and Sheryl will host the first such Board Meeting at her home on October 29 at 7 p.m.

On a motion by Sheryl that was seconded by Brenda, the meeting was adjourned.
