MINUTES, BOARD OF DIRECTOR'S MEETING April 29, 2008

<u>Members Present</u>: The members present included: Howard Dahlstrom, Rick Delaney, Tom Clay, Michelle Prinz, Bill Penn, Sheryl Topliff, Elgar Brown, Brenda Arnoczky, and Susie Cockerill.

The Board approved the Agenda (copy attached) and prior Board Meeting Minutes.

<u>Treasurer's Report</u>: Tom Clay presented the Treasurer's Report (copy attached) and the Board approved it on a motion by Elgar that was seconded by Brenda.

Review of Club Finances: Rick reported that one club in our district was recently the victim of embezzlement and the District is recommending that clubs obtain crime coverage for members with check signing authority. Bill also reported that at a recent Poker event a patron fell and broke his hip and is now suing Trippers. The lease with Trippers passes that liability on to the Charity. Bill suggested that we check to make sure that our liability coverage from Rotary International will protect us from this type of exposure. After discussion, it was decided that Rick will check with Andy Sheets about his recommendations for coverage. It was also decided that Rick will talk with Scot Hoskins about his recommendations for a club financial review. Consideration is to be given to simply having three members with financial backgrounds conduct a review without hiring a firm to do so formally.

<u>Fundraising Update</u>: Rick reported that we were successful in getting a \$5,000 grant for tree planting approved from the District. He also reported that we raised just shy of \$4,000 at the recent Poker Outing. These two items along with Duck Race Proceeds has put our finances in very good shape.

<u>International Project—Ecuador Water</u>: Sheryl reported that she would like to raise a total of \$3,000 to go toward the project. There is currently \$1,000 in the budget and she indicated she is making a \$1,000 contribution and we will ask club members to also make contributions. The contributions should be made to our club foundation.

<u>Lugnuts</u>: Rick reported that June 25, 2008 will be Rotary Day at Oldsmobile Park and special events are planned at the stadium for Rotarians on that day.

<u>Miscellaneous Issues</u>: Today's Bulletin was prepared by our new Bulletin Editor, Shannon Poynter. Thanks go to Shannon for taking this on as a new member.

Rick also announced that we need nominations for Rotarian of the Year.

We also discussed the lack of response from Webberville Schools regarding the \$500 we have in the budget for them. No response has been received from Webberville. There was discussion about reprogramming these dollars to the water project. It was decided that Rick will make one more contact before we do any reprogramming.

The Board discussed our next meeting date and it was decided to move it to June 4, 2008, tentatively to be held at Brenda's at 7:00 pm.
