MINUTES, BOARD OF DIRECTORS MEETING JUNE 4, 2008

MEMBERS PRESENT: Tom Clay, Michelle Prinz, Brenda Arnoczky, Rick Delaney, Susie Cockerill, Sheryl Topliff, Matt Maki, Bill Penn.

AGENDA: Rick added a discussion of the King River Rat and a Tree Update to the Agenda. The Agenda (copy attached) as adjusted was approved by the Board on a motion by Tom that was seconded by Bill.

MINUTES: The Board approved the prior minutes on a motion by Michelle that was seconded by Sheryl.

TREASURER'S REPORT: Tom gave the Treasurer's Report (copy attached). He also reported that he now has opened an account with Edward Jones for our Foundation. He also indicated that Fifth Third has again rejected being a sponsor for the duck race while Independent Bank has for the second year agreed to be a sponsor. The Board approved closing all accounts at Fifth Third and opening accounts to replace them at Independent Bank on a motion by Bill that was seconded by Susie. Tom reported that he has started work on the 2008-09 Budget and should have something for the Board at the next meeting. The Board approved the Treasurer's Report on a motion by Susie that was seconded by Sheryl.

WEBBERVILLE GRANT: After multiple attempts to get direction from Brian Friedel, Tom and Rick have been unable to get any guidance regarding where to send the \$500 approved from last year's duck race for the Webberville Schools. The Board decided to rescind approval for that grant. This was done during the Treasurer's Report and was covered by the action approving the Treasurer's Report.

INSURANCE REVIEW: Rick reported that he had received a recommendation from Andy Sheets regarding both liability and crime protection. Andy indicated that it was his opinion that the Club is adequately covered from a liability standpoint by our RI coverage. He did recommend that the Club purchase a fidelity bond to cover all officers and board members up to \$50,000. Rick will follow up with Andy and make a decision where to purchase the coverage. The Board approved this action.

FUNDRAISING: We only need 3 more people for the next poker outing. The duck race is coming along but we do need someone to fill in for Jim Siebert as King River Rat because he is not going to be able to fill that function as a result of his wife, Teri's health situation. There was much discussion and Rick is going to talk with Derick Nolan about being in charge this year. The "Duck Tagging" will occur on Wednesday June 11, 2008 at 6 pm at Tito's house. A lot of discussion followed and the Board really feels that a washing of the ducks is not necessary. Also,

WATER PROJECT: Sheryl reported that the combined check from Williamston and Lansing of something over \$22,000 has been sent. A project has been selected for the coming year. Between our club contribution and contributions by members we were able to send about \$2,400.

RYLA: Susie reported that we have named student participants from both Williamston and Webberville for this year. She also reported that a new Student of the Quarter Plaque has been purchased and delivered to the High School.
