Founder of Rotary

Paul P. Harris

1868—1947

Paul P. Harris, a lawyer, was the founder of Rotary, the world's first and most international service club. Harris was born in Racine Wisconsin, USA on April 19, 1868, Paul was the second of six children to George N. Harris and Cornelia Bryan Harris. Married to Jean Thompson Harris (1881 - 1963), they had no children. He received an L.L.B. from the University of Iowa and received an honorary L.L.D. from the University of Vermont.

Paul Harris worked as a newspaper reporter, a business teacher, stock company actor, cowboy, and traveled extensively in the U.S.A. and Europe selling marble and granite. In 1896, he went to Chicago to practice law. One evening Paul visited the suburban home of a professional friend. After dinner, as they strolled through the neighborhood, Paul's friend introduced him to various tradesmen in their stores. It was here Paul conceived the idea of a club that could recapture some of the friendly spirit among businessmen in small communities.

On February 23, 1905, Paul Harris formed the first club with three other businessmen: Sylvester Schiele, a coal merchant; Gustavus Loehr, a mining engineer; and Hiram Shorey, a merchant tailor. Paul Harris named the new club "Rotary" because members met in rotation at their various places of business. Club membership grew rapidly. Soon Paul became convinced that the Rotary club could be developed into an important service movement and strove to extend Rotary to other cities.

Paul was also prominent in other civic and professional work. Paul maintained his law office for most of his life. He spent much time traveling and was invited to speak to Rotarians at annual conventions, district and regional meetings, and other functions. When President emeritus Paul Harris passed away on 27 January 1947, his dream had grown from an informal meeting of four men to some 6,000 clubs. In the past five decades, the organization has grown to more than 31,500 clubs with 1.2 million members brought together through Paul Harris' vision of service and fellowship.



Object of Rotary

The object of Rotary is to encourage and foster the ideal of service as a basis of worthy enterprise and, in particular, to encourage and foster:

- 1 The development of acquaintance as an opportunity for service;**
- 2 High ethical standards in business and professions; the recognition of the worthiness of all useful occupations; and the dignifying by each Rotarian of his occupation as an opportunity to serve society;**
- 3 The application of the ideal of service by every Rotarian to his personal, business and community life;**
- 4 The advancement of international understanding, good will, and peace through a world fellowship of business and professional men united in the ideal of service.**

As his country's national PolioPlus chair, Ravindran headed a task force consisting of the government, UNICEF, and Rotary and worked closely with UNICEF to successfully negotiate a ceasefire with the northern militants during National Immunization Days. He also chaired the Schools Reawakening project, sponsored by Rotary clubs and districts in Sri Lanka, to rebuild 25 tsunami-devastated schools to benefit 15,000 children.

My Rotary experience began in 1976 with membership in Rotary Club of Cass City, Michigan. After moving to southwest Michigan I became a member of the Rotary Club of Vicksburg, and in 1987 I joined the Rotary Club of Kalamazoo. As a member of Kalamazoo Rotary, I have chaired five committees—Vocational Service, Sergeant-At-Arms, Group Study Exchange, Rotary Foundation and District 6360 Foundation.

My wife Penny and I have hosted numerous Group Study Exchange participants in our home, including young professionals from Germany, Chad and South Korea. I also served on the Board of Directors for five years and was President in 2003–2004. I served as an Assistant Governor for four years and have attended an International Convention and numerous District Conferences. In 2010, Penny (a member of Rotary Club of Portage, Michigan) and I co-chaired the District 6360 District Conference that created the concept of honoring a "Rotary Hero" from each club.

I am a Paul Harris Fellow +9 and a Major Donor to The Rotary Foundation. I created and organized a fundraising Concert to End Polio in cooperation with the Kalamazoo Symphony Orchestra, which also increased awareness of our Polio eradication efforts.

My professional career began in hospital administration in which I held various staff and management positions, including employment in various senior management capacities at Bronson Healthcare Group for over 16 years. During this time, I was elected to serve as the Chair of the Southwest Michigan Hospital Council and served a term on the Board of Directors of the Michigan Hospital Association. I was appointed CEO of Bronson Methodist Hospital and served in that capacity for five

years. After two years as a Corporate Vice President of Bronson Healthcare Group, I left to purchase a small publishing company, owning it 16 years and expanding it from publishing one magazine to publishing a newspaper for Kalamazoo Public Schools, multiple anniversary publications and a number of profitable event programs for festivals and major events in Kalamazoo.

I have been active in many volunteer and civic activities since moving to Kalamazoo in 1976. I served on the Parchment Board of Education and was Little League President and a Cub Scout Packmaster. I am a graduate of the 1988 Class of Leadership Kalamazoo and have served on the following Boards of Directors: Visiting Nurse Association; Downtown Kalamazoo; Founding Board Chair of West Michigan Cancer Center; West Michigan Air Care; Friends of Richmond Center for Visual Arts; WMUK Friends Advisory Committee; and Girl Scouts of Glowing Embers Council where I co-chaired a \$7 million capital campaign. My family hosted four high school students through foreign exchange programs and both of our sons were outbound exchange students.

I have always lived in Michigan, except while serving in the U.S. Army, first as a Military Policeman and then as a Drill Sergeant. I grew up in Grosse Pointe Farms and have a B.S. in Business Administration from Central Michigan University and a Master of Hospital Administration from University of Michigan.

Today, 42 million people are displaced by armed conflict or persecution. Rotary Peace Fellows develop the skills to strengthen peace efforts, train local leaders to prevent and mediate conflict, and support long-term peace building in areas affected by conflict.

FIGHTING DISEASE

More than 100 million people are pushed into poverty each year because of medical costs. Our members educate and mobilize communities to help prevent the spread of polio, HIV/AIDS, and malaria. Many of our projects ensure that medical training facilities are located where the workforce lives.

PROVIDING CLEAN WATER

More than 2.5 billion people lack access to adequate sanitation facilities. Our projects give communities the ability to develop and maintain sustainable water and sanitation systems and support studies related to water and sanitation.

SAVING MOTHERS AND CHILDREN

At least 7 million children under the age of five die each year due to malnutrition, poor health care, and inadequate sanitation. To help reduce this rate, we provide immunizations and antibiotics to babies, improve access to essential medical services, and support trained health care providers for mothers and their children.

SUPPORTING EDUCATION

Sixty-seven million children worldwide have no access to education and more than 775 million people over age 15 are illiterate. Our goal is to strengthen the capacity of communities to support basic education and literacy, reduce gender disparity in education, and increase adult literacy.

GROWING LOCAL ECONOMIES

Nearly 1.4 billion employed people live on less than \$1.25 a day. We carry out service projects that enhance economic and community development and develop opportunities for decent and productive work for young and old.





