## Founder of Rotary Paul P. Harris 1868–1947

Paul P. Harris, a lawyer, was the founder of Rotary, the world's first and most international service club. Harris was born in Racine Wisconsin, USA on April 19, 1868, Paul was the second of six children to George N. Harris and Cornelia Bryan Harris. Married to Jean Thompson Harris

(1881 - 1963), they had no children. He received an L.L.B. from the University of Iowa and received an honorary L.L.D. from the University of Vermont.

Paul Harris worked as a newspaper reporter, a business teacher, stock company actor, cowboy, and traveled extensively in the U.S.A. and Europe selling marble and granite. In 1896, he went to Chicago to practice law. One evening Paul visited the suburban home of a professional friend. After dinner, as they strolled through the neighborhood, Paul's friend introduced him to various tradesmen in their stores. It was here Paul conceived the idea of a club that could recapture some of the friendly spirit among businessmen in small communities.

On February 23, 1905, Paul Harris formed the first club with three other businessmen: Silvester Schiele, a coal merchant; Gustavus Loehr, a mining engineer; and Hiram Shorey, a merchant tailor. Paul Harris named the new club "Rotary" because members met in rotation at their various places of business. Club membership grew rapidly. Soon Paul became convinced that the Rotary club could be developed into an important service movement and strove to extend Rotary to other cities.

Paul was also prominent in other civic and professional work. Paul maintained his law office for most of his life. He spent much time traveling and was invited to speak to Rotarians at annual conventions, district and regional meetings, and other functions. When President emeritus Paul Harris passed away on 27 January 1947, his dream had grown from an informal meeting of four men to some 6,000 clubs. In the past five decades, the organization has grown to more than 31,500 clubs with 1.2 million members brought together through Paul Harris' vision of service and fellowship.

## **Mark Daniel Maloney**

"The clubs are where Rotary happens," says Maloney, an attorney. He aims to support and strengthen clubs at the com-

munity level, preserve Rotary's culture as a service-oriented membership organization, and test new regional approaches for growth. "With the eradication of polio, recognition for Rotary will be great and the opportunities will be many," he says. "We have the potential to become the global powerhouse for doing good."

A Rotarian since 1980, Maloney has served as an RI director; Foundation trustee and vice chair; and aide to 2003-04 RI President Jonathan Majiyagbe. He also has participated in the Council on Legislation as chair, vice chair, parliamentarian, and trainer. He was an adviser to the 2004 Osaka Convention Committee and chaired the 2014 Sydney Convention Committee.

Prior to serving as a District Governor, Maloney led a Group Study Exchange to Nigeria. He also served as Future Vision Committee vice chair; Foundation training institute moderator; Foundation permanent fund national adviser; member of the Peace Centers Committee; and adviser to the Foundation's Water, Sanitation, and Hygiene in Schools Target Challenge Committee.

## **ROTARY INTERNATIONAL AREAS OF FOCUS**

#### **PROMOTING PEACE**

Today, 42 million people are displaced by armed conflict or persecution. Rotary Peace Fellows develop the skills to strengthen peace efforts, train local leaders to prevent and mediate conflict, and support long-term peace building in areas affected by conflict.

#### **FIGHTING DISEASE**

More than 100 million people are pushed into poverty each year because of medical costs. Our members educate and mobilize communities to help prevent the spread polio, HIV/AIDS, and malaria. Many of our projects ensure that medical training facilities are located where the workforce lives.

#### **PROVIDING CLEAN WATER**

More than 2.5 billion people lack access to adequate sanitation facilities. Our projects give communities the ability to develop and maintain sustainable water and sanitation systems and support studies related to water and sanitation.

#### SAVING MOTHERS AND CHILDREN

At least 7 million children under the age of five die each year due to malnutrition, poor health care, and inadequate sanitation. To help reduce this rate, we provide immunizations and antibiotics to babies, improve access to essential medical services, and support trained health care providers for mothers and their children.

#### SUPPORTING EDUCATION

Sixty-seven million children worldwide have no access to education and more than 775 million people over age 15 are illite rate. Our goal is to strengthen the capacity of communities to support basic education and literacy, reduce gender disparity in education, and increase adult literacy.

#### **GROWING LOCAL ECONOMIES**

Nearly 1.4 billion employed people live on less than \$1.25 a day. We carry out service projects that enhance economic and community development and develop opportunities for decent and productive work for young and old.


