

Corporate Membership Program

The Rotary Club of Northville (founded in 1926) is pleased to offer a “**Corporate Membership Program**” to local companies, municipalities, civic organizations, educational institutions or the like (hereinafter referred to as the “Company”) who have an interest in belonging to our diverse Club which offers community service projects, fund raising events and social/fellowship opportunities as time/interest permits. Our Club meets on the 2nd and 4th Tuesday of every month at the First Presbyterian Church of Northville located at 200 E. Main St, Northville, MI 48167. Rotary Clubs have no religious or political affiliation.

Benefits to the Company:

1. Ability to develop new relationships with other business and community leaders,
2. Ability to leverage your time and see improved results in community outreach, making a difference in the lives of others,
3. Opportunities for leadership development,
4. Positive exposure for your Company in the community.

Membership Process:

1. **Approval:** A corporate entity or organization shall submit the Corporate Membership application (page 2) for membership and may become an “Eligible Corporate Member” of the Northville Rotary club following the approval process established by the Club’s Board of Directors.
2. **Named Corporate Members:** Once an entity becomes an “Eligible Corporate Member”, it may appoint up to four (4) persons to be its designated “Company members” We respectfully request that the Company name a “key managerial employee” as its **Primary Club Member**. The other named applicants (max 3) should come from other key roles/departments from within your “company” and will be considered **Associate Members**.
3. The **Primary Club Member** shall be listed on the rolls of Rotary International as the official member of the Northville Club. This member shall have all the rights and privileges of regular club members including the ability to hold office, serve on the Club or Club Foundation Boards, lead committees, attend District and International events and vote on all club matters. Additionally, all Primary Club members will be given a new member package including a Rotary Pin, Name badge and subscription to “the Rotarian” monthly magazine.
4. Each **Associate Member** shall receive a Rotary pin, name badge and subscription to “The Rotarian” magazine and is encouraged to attend club meetings, participate in committees, event planning and social functions as well as District/Rotary International events.
5. An **Associate Member (singular)** may be given proxy to vote on club matters in the event the **Primary Club** member is absent from a meeting or function where voting is conducted.
6. **Changing “Company Members”:** The Club will allow the Company to change any of its **Primary** (1) or **Associate Members** (3) so long as at all times one member is a “key managerial employee” of the Company. For continuity and administrative reasons, we request that you do not change any Company members more than once per year unless that member is no longer employed by your Company.
7. **New Member Induction:** All Company Members will be formally inducted/introduced into the club at a regularly scheduled Club meeting.
8. **Classification.** The classification of the eligible Company will be established by the club.
9. **Rotary Dues/Fees/Meeting expense.** The Clubs’ annual dues for a Corporate Membership shall be \$500/year, billed semi-annually to the Primary Member. There will be a \$25 processing fee for the Company’s application and all Company Members will be responsible for their own lunch fee of \$10 for each meeting attended. (payable at the door)
