also provided guidance in resume writing and interviewing. "The best part," said Menis, "was seeing young people apply for their first job!"

Edward Hospital Joins Merger Parade "Overarching Trend"

The December 31 merger of Edward-Elmhurst and Northshore health systems was an imperative, according to Edward Hospital CEO **Joe Dant**.

"There's an overarching trend among hospitals, physician groups, and insurance companies to consolidate. Size is an advantage when negotiating purchasing prices with vendors and insurance companies," Dant told our January 7 breakfast. He said larger systems are better positioned to deal with the Covid epidemic and the shortage of nurses.



"Since the advent of Covid, we have had a significant increase in turnover...more nurses and clinical staff workers are retiring or finding jobs outside of health care. Dant noted that nurses can double their salaries by moving

to private health care agencies. "We're stuck in a cycle; we've had to increase our pay rates to keep nurses from leaving."



The merger encompasses Evanston, Skokie, Glenbrook, and Highland Park hospitals; Swedish Hospital on Chicago's North Side; Northwest Community Hospital in Arlington Heights; Edward Hospital in Naperville; Elmhurst Hospital; and Linden Oaks Behavioral Health.
