Know Your Rotarian Ron Amato

Lisle Attorney **Ron Amato**, who joined our Club this past July, has experience with several local nonprofit organizations. The list includes the Exchange Club, Firefighters Pension Fund, Kids Matter, the Naperville Jaycees, the Last Fling, the Century Walk, and the Naperville Art Forum.



Ron and his wife, Amy, have been married 25 years. They have two children: **Alex**, an aspiring musician, is an incoming freshman at North Central College, and **Ellie**, who attends Naperville North High School.

Ron has fond childhood memories of riding his bike around DuPage county, saying his paraents often had no idea where he had gone. “We kids would ride all the way to Woodridge. We didn’t have cell phones or other electronic distractions.” But they did have the community swimming pool, athletic facilities, the creek that was eventually displaced by Interstate 355, and hanging out at McDonald’s.

After graduating from Northern Illinois University in 1993, Ron earned a law degree from the Chicago Kent College of Law and passed the Bar Exam on first try. Then came a job doing financial services litigation and a chance meeting with Amy in a bar following a Cubs game. They were married in 2000 and moved to Naperville in 2003. Nine years later, Ron started his own law firm specializing in insurance and professional liability claims for financial advisors.
