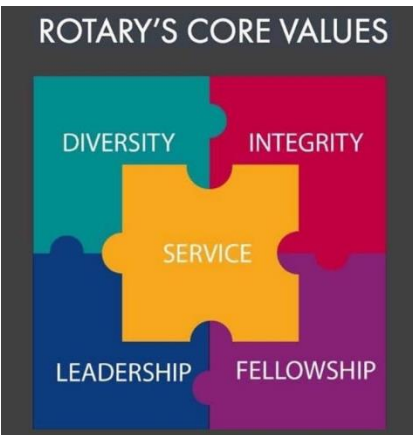

PAUL HARRIS 1868 – 1947



Paul Harris, the founder of Rotary, was born in Racine, Wisconsin, on April 19, 1868, but moved at the age of 3 to Wallingford, Vermont, to be raised by his grandparents. In the forward to his autobiography, *My Road to Rotary*, he credits the friendliness and tolerance he found in Vermont as his inspiration for the creation of Rotary.

Trained as a lawyer, Paul gave himself five years after his graduation from law school in 1891 to see as much of the world as possible before settling down and hanging out his shingle. During that time, he traveled widely, supporting himself with a great variety of jobs. He worked as a reporter in San Francisco, a teacher at a business college in Los Angeles, a cowboy in Colorado, a desk clerk in Jacksonville, Florida, a tender of cattle on a freighter to England, and a traveling salesman for a granite company, covering both U.S. and Europe.

Remaining true to his five-year-plan, he settled in Chicago in 1886, and it was there on the evening of February 23, 1905, that he met with three friends to discuss his idea for a businessman's club. This is commonly regarded as the first Rotary Club meeting. Over the next five years, the movement spread as Rotary Clubs were formed in the U.S. cities. When the National Association of Rotary Clubs held its first convention in 1910, Paul was elected President.

After his term, and as the organization's first only president-emeritus, Paul continued to travel extensively, promoting the spread of Rotary both in the USA and abroad. A prolific writer, Paul wrote several books about the early days of the organization and the role he was privileged to play in it. These include *The Founder of Rotary*, *This Rotarian Age* and the autobiographical *My Road to Rotary*. He died in Chicago on January 27, 1947.

ROTARY INTERNATIONAL PRESIDENT: SHEKHAR MEHTA, 2021-22



Rotary Club of Calcutta-Mahanagar, West Bengal, India

Mehta, an accountant, is chair of the Skyline Group, a real estate development company he founded. He is also a director of Operation Eyesight Universal (India), a Canada-based organization.

Mehta has been actively involved in disaster response and is a trustee of ShelterBox, UK. After the 2004 Indian Ocean tsunami, he helped build nearly 500 homes for families affected by the disaster.

He pioneered a program that has performed more than 1,500 life-changing heart surgeries in South Asia. He is also the architect of the TEACH Program, which promotes literacy throughout India and has reached thousands of schools.

A Rotary member since 1984, Mehta has served Rotary as director, member or chair of several committees, zone coordinator, training leader, member of The Rotary Foundation Cadre of Technical Advisers, and district governor. He is also the chair of Rotary Foundation (India).

Mehta has received Rotary's Service Above Self Award and The Rotary Foundation's Citation for Meritorious Service and Distinguished Service Awards.

He and his wife, Rashi, are Major Donors and members of the Bequest Society.

ROTARY INTERNATIONAL DIRECTOR 2021-23 – ZONES 30-31: ELIZABETH USOVICZ



Rotary Club of Kansas City Plaza, Kansas City, MO

Elizabeth Usovicz is a 23-year Rotarian, and currently serves as Director on the RI Board of Directors for 2021-23. She is a past president of the Kansas City Plaza Rotary Club and served as the District Governor for D6040 (MO) in 2008-09. Elizabeth is a recipient of The Rotary Foundation's Citation for Meritorious Service. Elizabeth received the US President's Volunteer Service Award in 2011 and 2012 and was recognized at the White House as a Rotary Women of Action honoree in October 2014.

Her passion in Rotary is supporting orphans and at-risk children in Malawi. She has written 10 Rotary Foundation grants to help Malawi's children and led a vocational training team that worked with local primary school teachers to develop and implement a program that encourages children, especially girls, to stay in school. Other grant projects have focused on a malaria bed net initiative in the southern region of Lake Malawi. "We helped reduce the mortality rate of children under five by 80% in that region — that's the power of 'we' in Rotary," Usovicz says. "I am not a medical professional, but when we collaborate like that in Rotary, we become lifesavers."

Usovicz has received The Rotary Foundation's Citation for Meritorious Service and has twice received the U.S. President's Volunteer Service Award. In 2014, Usovicz was recognized at the White House as a Rotary Women of Action honoree.

A native of Salem, Massachusetts, she appreciates history and her Lithuanian heritage. She also enjoys music, classic films, and science fiction TV. Usovicz and her husband, Dean Mathewson, are both Major Donors and Bequest Society members. They live in Westwood, Kansas.

After graduating from the University of Louisville in 1985, she began her career as a CPA with the multinational firm of PriceWaterhouse Coopers in Louisville, KY. Nancy started her own CPA practice in 1991, where she and her husband continue to practice and care for their clients. She is highly active in her community and serves on several Boards including the LGE/KU Consumer Advisory Board, the Historic Preservation District Board, the Housing Authority Board of Commissioners, and as an adviser to the City of Greensburg City Council.

Nancy is married to fellow Rotarian, PDG Otha Ray Stearman (2019-20). They are RI Foundation Major donors, members of the Bequest Society, multiple Paul Harris Fellows and members of the Paul Harris Society. 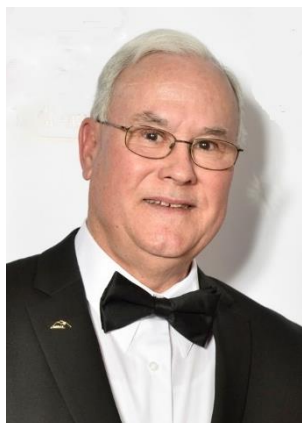
DISTRICT TRAINER: JAYNE CRISP, PDG 2014-15

The bank eventually merged, along with nine other community banks in Central Kentucky, to form Forcht Bank. He continues to serve on the Board of Directors of Forcht Bank.

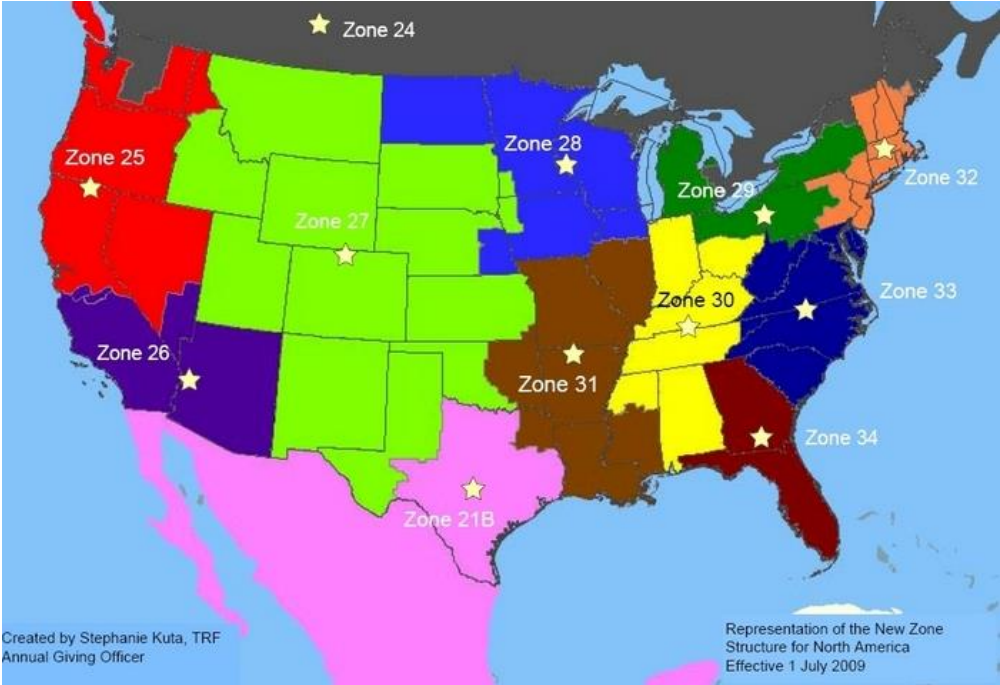

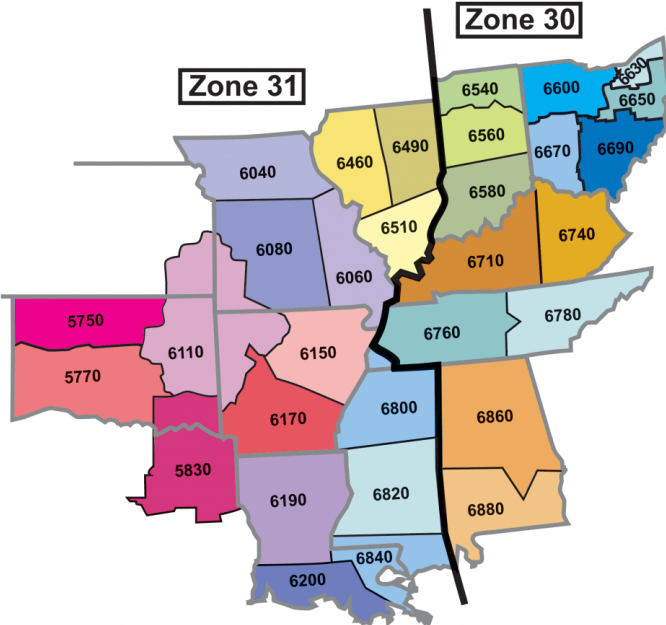
ZONE INFORMATION

2. Is it **FAIR** to all concerned?
3. Will it build **GOODWILL** and **BETTER FRIENDSHIPS**?
4. Will it be **BENEFICIAL** to all concerned?

ROTARY CODE OF CONDUCT

As a Rotarian, I will:

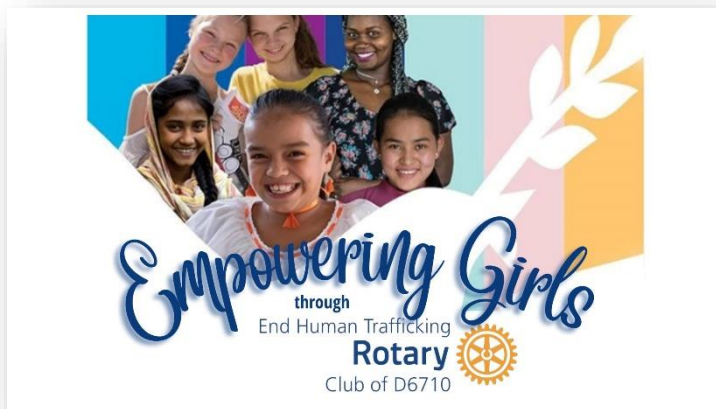
1. Act with integrity and high ethical standards in my personal and professional life

3. Use my professional skills through Rotary to mentor young people, help those with special needs, and improve people's quality of life in my community and in the world

5. Help maintain a harassment-free environment in Rotary meetings, events, and activities; report any suspected harassment; and help ensure non-retaliation to those individuals that report harassment.

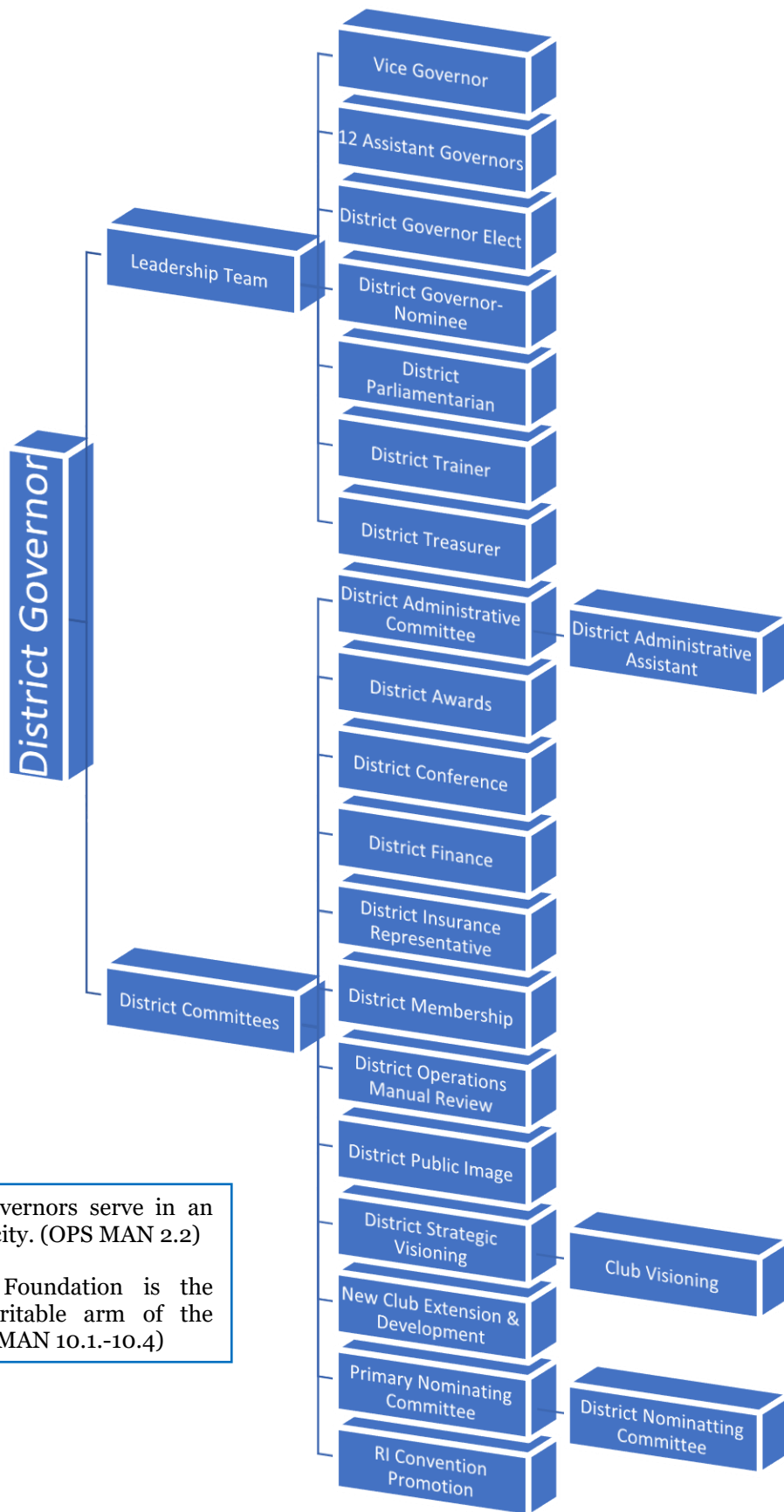

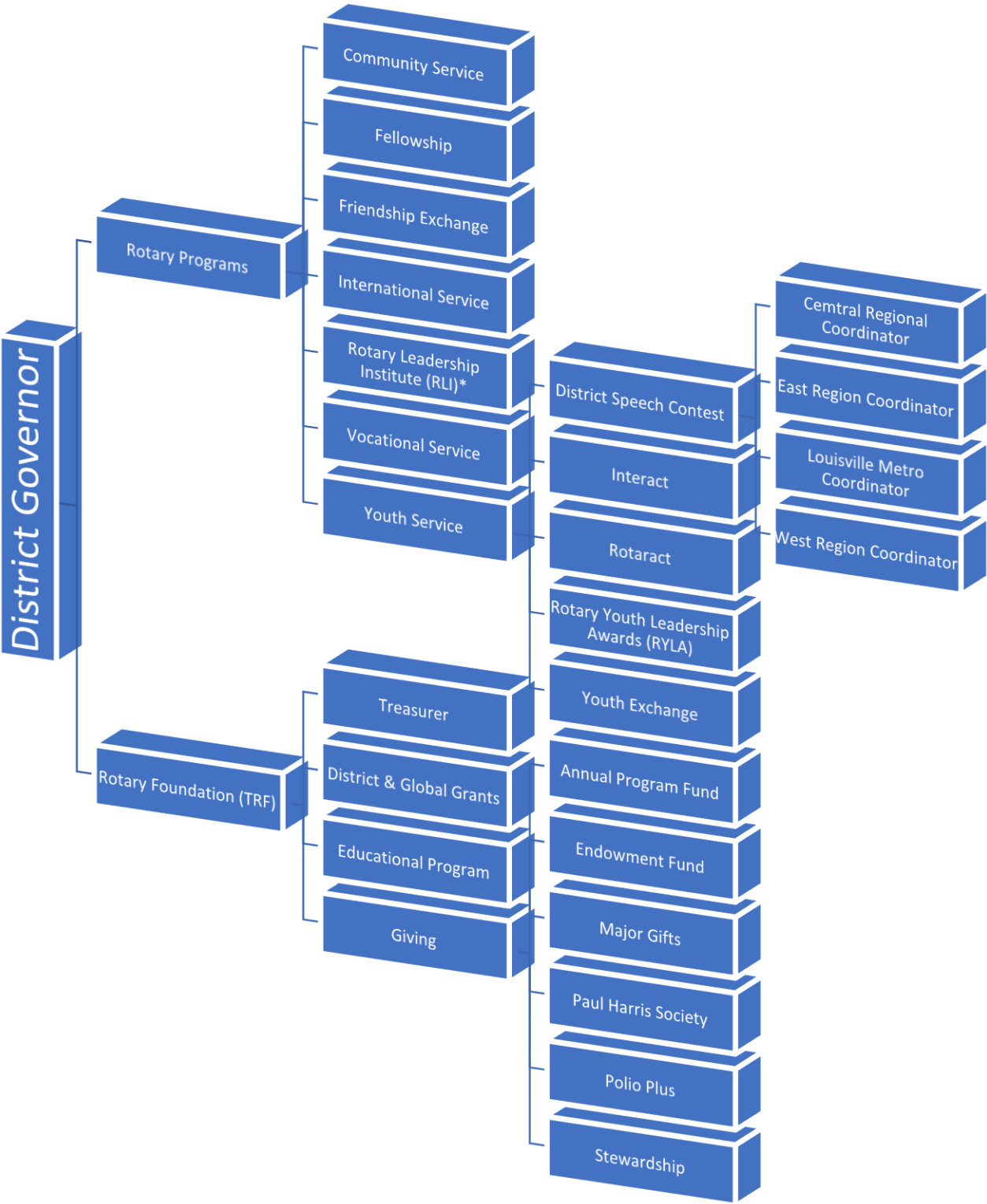
DISTRICT ORGANIZATIONAL CHART

GROUP STUDY EXCHANGE TEAM ALUMNI

The Group Study Exchange (GSE) program, funded by The Rotary Foundation until 2013, provided a unique cultural and vocational exchange opportunity for business people and professionals between the ages of 25 and 40 who were in the early stages of their careers. The focus was to develop professional and leadership skills among young adults for them to address the needs of their communities and an increasingly global workplace. The program provided travel grants for teams consisting of four to six team members plus a Rotarian team leader to exchange visits in paired areas of different countries. For four to six weeks, team members stayed in the homes of Rotarian when possible, and experienced the host country's culture and institutions, observed how their vocations are practiced abroad, developed personal and professional relationships, and exchanged ideas, all to enhance Rotary's worldwide mission.

AMBASSADORIAL SCHOLARS ALUMNI

From 1947 to 2013, nearly 38,000 men and women from about 100 nations studied abroad under the auspices of the Ambassadorial Scholarship program. It was the world's largest privately funded international scholarships program. The purpose of the Ambassadorial Scholarships program was to further international understanding and friendly relations among people of different countries. The program sponsored several types of scholarships for undergraduate and graduate students as well as for qualified professionals pursuing vocational studies. While abroad, scholars served as ambassadors of goodwill to the people of the host country and provided presentations about their homelands to Rotary clubs and other groups. Upon returning home, scholars shared with Rotarians and others the experiences that led to greater understanding of their host countries.

BRIEF HISTORY OF ROTARY DISTRICT 6710

The first Rotary District to which Kentucky clubs were assigned was District 6, established in 1915-16. It embraced all of the four states of Arkansas, Kentucky, Mississippi and Tennessee. In 1917-18, the territorial limits of District 6 were changed to remove Mississippi. In 1922-23, District 23 was formed including in its territory all of Kentucky, all of Tennessee except the county of Shelby and a part of Virginia (that portion west of the eastern boundaries of the counties of Tazewell, Smyth and Washington).

In 1925-26, Kentucky was made a District by itself (18). This arrangement continued until 1937, when the annual Conference of District 18, held at Lexington, voted to divide Kentucky into two Districts. W. L. Matthews, of Bowling Green, was elected Governor of the new 161st District embracing Western Kentucky clubs and O.O. (June) Thompson, of Newport, was elected Governor of the new District 162 (Eastern Kentucky). Territory then assigned to District 161 included that portion of the state west of the western boundaries of the counties of Boone, Grant, Scott, Fayette, Jessamine, Garrard, Lincoln, Pulaski, and McCreary counties.

During the Rotary year 1942-43 a slight change was made in the territorial limits of District 161 by reassigning Woodford County to District 162. That change was effective January 1, 1943.

In 1949-50, District 233 was created and all the territory previously embraced by District 161 was assigned thereto. There were no boundary changes.

In 1957-58, District 671 was formed encompassing the territory previously assigned to District 233. There have been no subsequent changes in its territorial limits.

As of July 1, 1991, all existing Districts had a zero (0) added to their District number. Hence, 671 became 6710.
