

### ANNUAL FUND GIVING PROVIDES **DISTRICT GRANTS**

This is a reminder that district grant money comes from Annual Fund giving. Clubs that give more per member, get more, when they apply for district grants.

Two Year Average per Member Matching Amount:

- \$100 and above \$1.50 for \$1.00
- \$75 \$99.99 \$1.00 for \$1.00
- Below \$75 \$0.75 for \$1.00

FOUNDATION

As of January 31, our giving to the Annual Fund SHARE is \$44.11 per Rotarian (Goal is \$100.) The goal by year end is \$100 per Rotarian and in 2018 we were at \$46.75 per member. Thanks to the 812 District Rotarians who have contributed so far this year. (30% vs goal of 50%) Attached is a ranking by average contribution per club member for the four divisions of membership as well as what each club had given at this point last year. Read More

### 2019 Council on Legislation

Every three years the Rotary International Council on Legislation convenes. Each of the 529 Rotary Districts is represented by a past District Governor serving as a voting delegate. The next will be held in Chicago April 14.19, 2019. The delegates will review a



be held in Chicago April 14-18, 2019. The delegates will review and vote on 116 proposed enactments to the Rotary International Constitution, the Rotary International Bylaws and the standard Rotary club constitution.

Delegates are asked to consider how each enactment will affect Rotary International as the world-wide organization it is. The enactments have been proposed by Rotary Districts and Clubs around the world, as well as the Rotary International Board of Directors.
