DG Argo seconded motion.

Agenda accepted.

Corrections were identified for the minutes from the Fall COG Meeting. Action listed on Fall minutes, PDG Drinkard to provide copy of DDF and provided to Secretary Evans.

MOTION:

PDG Valieant moved that minutes be accepted. PDG Andrew seconded motion. Minutes accepted and approved.

Finance Committee Update: PDG Andrew, Finance Committee Chair

- Clubs in Arrears Document
 - Last Finance Committee, reviewed report that showed several Clubs had not paid dues to RI and District
 - o Appointed a committee to review: Ronnie Dukes, Danny Cooner, PDG Bo Porter, and Andrew.
 - Came up with a policy that comes with Clubs that have not paid dues. In clarification DG Argo said that all Clubs have paid District and RI dues. This policy had been added to DLP - on District web site under leadership.

ACTION: Andrew will bring copies to the next meeting

- Reviewed 990 that was due in November and has been submitted
- Reviewed financials from DG Argo and Ronnie Smallwood. Everything was in order and balanced.
- Reviewed DGE Bill Petty budget and with some discussion it was approved.
- Reviewed changes to Finance Committee Composition and that is now in the Finance Committee working.
- PDG Wade Drinkard reported District Programs

Call for questions.

Cross asked for the changes to the Finance Committee composition to be shared. PDG Porter read:

The District Finance Committee is comprised of thirteen members: the PDG Chair, the DG, the IPDG, the DGE and the District Treasurer as ex-officio voting members; the DGN and the District Treasurer as ex-officio non-voting members; and six at large voting members.

The District Governor two years removed from the office will serve as the Finance Committee's chair. All ex-officio members serve one year terms concurrent with their terms of office. At-large members shall serve a staggered three-year term such that the terms of two members expire each year. The District Governor shall appoint Rotarians as members at-large to fill positions becoming vacant upon his/her accession to office. At least one of the two members appointed each year shall be a Past District Governor. No at-large member appointment shall be made of a Rotarian from the same club as or any club of a club group as any Rotarian already holding membership on the committee. Ex-officio members may, by necessity, election or appointment be from same clubs or club groups.

Cross clarified that by "groups" it is referring to Assistant Governor. Also, Treasurer is mentioned as ex-officio twice; however, District Secretary is not.

Porter corrected that the District Treasurer as ex-officio non-voting, should actually be District Secretary.

Change above from: *the DGN and the District Treasurer as ex-officio non-voting members* To: *the DGN and the District Secretary as ex-officio non-voting members*

PDG Hadden asked that it be sent to everyone.

Action: Andrew will send out for COG to approve (with changes mentioned).

Porter clarified that COG will approve to make recommendation to DG for decision (according to DLP)

Council on Legislation Update: PDG Mary Jean Sanspree could not be at meeting today

Cross asked for any known updates.

RIPE Maloney reported it will start on Palm Sunday and will end on Thursday at noon.

With new process, all resolutions are moved to online consideration.

COL will be completed much more quickly.

Wide range of subjects from Rotaract to Council on Legislation itself to Rotary International changing its tax status

PDG Porter asked: assuming that the Legislation passes to change the term of representative of the district to 4 years instead of 2 and the paired Zones recommendation goes through where there will be a COL every 2 year. What is the impact on the District of the required pre planning training fin advance of participation at the Council?

Maloney said as he understands it, only the representative who will actually attend will be required training (every 4 years).

Maloney pointed out that this project was featured at International Assembly with a presentation by PRIP Ravi Ravendrum and Birmingham Rotarian Dr. Partridge (recipient of Vocational award last year). Wonderful presentation! This was significant not just to show it was a great project, but also to show what you can do with International partnerships and the relationships this develops between Rotary Club of Birmingham and Rotary Club in Sri Lanka.

7 projects mentioned – our District has committed a total of \$115,621 DDF.

These projects total \$1,151,153. Our District and our Clubs are to be congratulated. The money they are giving to Annual fund is a huge return on investment.

Note, Ron Brown has resigned. The new team includes: Kathy Brunot (District grants) and Brian Stallings (Global Grants). Both are from the Rotary Club of Tuscaloosa.
