
# Experience ALOHA at RI Convention 2020

# Council on Legislation Nominations Open

#### Council on Resolutions

The Council on Resolutions meets online every year to vote on proposed resolutions. Resolutions are requests to the Board or the Trustees to take an action that is outside the purview of the constitutional documents. Ideally, a resolution should affect the Rotary world, rather than address local or administrative issues.

Representatives from all Rotary districts vote on resolutions proposed by clubs, districts, the RI Board, and the general council or conference of RIBI. Adopted resolutions are then considered by the RI Board or The Rotary Foundation Trustees

The Council on Resolutions will take place 15 October through 15 November. You can view resolutions on line beginning 1 October. Voting will close 15 November at 23:59 Chicago time (UTC-6). The results will be published by 20 November. Any Rotarian can view the resolutions and the results, but only representatives can vote.

#### Council on Legislation

Every three years, Rotarians meet at the Council on Legislation to review and vote on proposed changes to the legislation that governs Rotary. They consider enactments, which change Rotary so governing documents, and position statements by the RI Board.

#### Council representatives

Each Rotary district chooses a representative for a three-year term. These members represent their districts at all three meetings of the Council on Resolutions and at the Council on Legislation during their term.

Every district selects a representative to serve at the Councils on Resolutions and the Council on Legislation that take place during their Council term from 1 July 2020 through 30 June 2023. The Council representatives will represent their district at the:

2020, 2021, and 2022 Councils on Resolutions 2022 Council on Legislation

Representatives and alternates must be selected by 30 June 2020 and reported to Rotary International. Selection requirements and duties for representatives can be found in Article 9 of the RI Bylaws

#### Eligibility

To serve as representative, a candidate must:

Be a member of a club in the district: Have served a full term as district governor at the time of election; Be able to complete mandatory Council training: Be digitally literate for communication, reviewing documents, and voting; and Be able to attend the Council on Legislation for its entire duration. Representatives Duties

Duties of a Council representative are as follows:

Assist clubs in preparing proposed resolutions and enactments; Discuss proposed resolutions and enactments at district meetings; Be knowledgeable of the attitudes of Rotarians within the district; Give critical consideration to all proposed resolutions and enactments and effectively communicate their views on such proposals to the Councils; Act as an objective legislator; Participate in the Councils on Resolutions; Attend the Council on Legislation for its full duration; and Report on the deliberations of the Councils to the clubs in their district following the meetings of the Councils. Representatives are also required to complete an online representative course and Council training at their 2021 Rotary Institute in preparation for the 2022 Council on Legislation. Their participation at the Institute is not funded by Rotary International.

#### District 6890 Election Procedure

In the Rotary year two (2) years preceding that in which the Council on Legislation is to meet and not less than 3 months prior to the District Conference, the DG shall solicit nominees for election as the district representative to the RI Council on Legislation. Responses shall be required not later than one month following the publication of the call for nominees and the list of nominees will be published in the District Governor s Newsletter immediately preceding the bistrict Conference. Except as provided by the RI Bylaw 8.060 (Ballot by Mail), the representative and alternate representative to the Council of Legislation shall be elected by club Electors at the district Business Meeting held at the District Conference. The election procedure shall be as set forth in RI Bylaw 8.050. No district representative shall serve more than twice in succession in this capacity.

## Some Interesting Facts...



Here are some interesting facts about our Rotary Foundation during the 2018-19 Rotary Year:

#### PolioPlus

Since 1988, Rotary and its partners have immunized more than 2.5 billion children against polio. As of June 2019, Rotary had committed \$2 billion to global polio eradication. The goal is to eliminate the virus in the last three countries where it remains endemic and to keep it from returning anywhere else. In 2018-19, program awards, including PolioPlus Partners grants, totaled \$151.2 million. Rotary Peace Centers

Each year, the Foundation supports the training of peace fellows at six Rotary Peace Centers, where they earn master laws degrees or professional

development certificates. Since 2002-03, 1,284 fellows have graduated from the Peace Centers and are working in more than 116 countries. In 2018-19, 94 fellows from 43 countries began their studies at the Rotary Peace Centers, and program awards for the fellows and centers totaled \$5.0 million. District grants

District grants support small-scale, short-term projects related to the Foundation s mission. In 2018-19, the Foundation approved 494 district grants, and program awards totaled \$26.3 million.

Global grants Global grants Global grants fund large-scale international activities with sustainable, measurable results that support Rotary s six areas of focus. Activities include humanitarian projects, scholarships, and vocational training teams. In 2018-19, the Foundation approved 1,403 global grants, and program awards totaled \$86.6 million.

In 2018-19 The Rotary Foundation received a total of \$321.9 million in outright contributions and disbursed \$301.4 million in program awards and operations. Thanks to The Rotary Foundation, we Rotarians get a lot done "in our spare time!"
