Subject: Minutes of the Board of Directors Meeting on September 6, 2022

- 1. Meeting called to order at: 12:15 PM
- 2. Board Members:
 - a. <u>Present</u> Joshua Stewart, Carlos Román, Bruce Lybarger, Jeff Roth, Angela Cowden, Chip Boring, Debbie Cwalinski, Shawn Martz, and Scott Noethlich. Also present were Kim Heintz, and Jon Layton.
 - b. <u>Members Absent</u> Rob Livingston, Liz Fischer, Heather Beato, Eric Zwayer, Debra Weiser, Bryant Musselman, Cyndi Sue Dassinger, and Gil Riordan.
- 3. Invocation: By _____
- 4. <u>Approval of Minutes</u> Minutes for the meeting on August 2 and August 4, 2022, were read. Chip Boring moved, seconded by Scott Noethlich, to approve the minutes. After discussion, the motion passed.
- 5. President's Report: Josh Stewart reported:
 - a. Are you Smarter than a Rotarian? Josh Stewart wanted to assess from Jeff Roth and the board the feasibility to execute the event in March 2023. Jeff Roth reported that the location needs to be secured, that donations have traditionally covered 2/3 of the costs including grants to the schools, and only the Noon and Evening Clubs may participate. Jeff Roth was committed to plan for it.
 - b. President Elect/Fundraising Chair
 - (1) <u>President Elect</u> No update, still working to secure a candidate.
 - (2) <u>Fundraising Chair</u> Liz Fisher resigned as chair. A new chair would need to be recruited.
 - c. <u>1st Responder's BBQ</u> Event is scheduled for Friday, October 28. Volunteers will be recruited during regular meetings.

d. <u>Bank Accounts</u> – Almost all the funds from Sunrise Club have been transferred to the new bank accounts with MidFlorida Credit Union.

- e. <u>Freedom Flight</u> The 40 and 8th Veteran's Group donated \$625 toward the costs of the event. Since the club has already paid for the veterans, Josh suggested splitting the donation evenly among the guardians. Chip Boring moved, seconded by Carlos Román, to split the gift evenly among the guardians. After discussion, the motion passed.
- f. <u>Lunch Prices</u> Josh Stewart asked the management of the restaurant for an estimate to provide a lunch buffet at a lower price. A buffet would also reduce the waiting time for food to be served. More to come.
- 6. Immediate Past President / Vice President: Heather Beato and Eric Zwayer, no present.
- 7. President Elect: Vacant.
- 8. Secretary: Carlos Román No report.
- 9. Treasurer Bruce Lybarger

 - (2) Josh Stewart provided copies of bank statements for August 2022 for old Sunrise Club accounts with MidFlorida, savings accounts # 1156 and checking account # 1143, and the Foundation savings account # 1198 and checking account # 1211. See copies at Enclosures 5 and 6.
 - b. Overdue Accounts Bruce Lybarger reported that 1/3 of members are behind paying their quarterly dues. Multiple statements have been sent as reminders. Kim Heintz and Chip Boring volunteered to call members; Bruce to provide names.

- c. <u>Joan Fisher Status</u> Angela Cowden reported that Joan Fisher's physical condition has declined materially; she is residing in a facility in Orlando near her children. Carlos Román moved, seconded by Angela Cowden, to reclassify her membership from Active R-85 to Honorary. After discussion, the motion passed. Carlos will try to communicate with Joan Fisher. Angela Cowden will get a "Get Well" card to be signed by the members to send to her.
- d. <u>RI Convention</u> The next event is scheduled for June 2023 in Melbourne, Australia. A discussion was held as to whether there was an interest in partially fund one member to attend the convention. Both Sunrise and Noon Clubs have traditionally included an amount for this in the budgets. No commitment/conclusions were reach on this matter.
- e. <u>Apple Sale</u> Bruce Lybarger reported that Terrill Morris has called him with an idea on how to do a scale down apple sale. Bruce Lybarger conveyed to him that the club has already three fund raising events scheduled this year and that there are no resources or time available for an apple sale. No motion was raised on this matter.


