Subject: Minutes of the Board of Directors Meeting on July 5, 2022

1. Meeting called to order at: 7:09 AM

2. Board Members:

- a. <u>Present</u> Joshua Stewart, Heather Beato, Carlos Román, Debbie Cwalinski, Liz Fischer, and Scott Noethlich.
- b. <u>Members Absent</u> Eric Zwayer, Bruce Lybarger, Jeff Roth, Debra Weiser, Bryan Musselman, Chip Boring, Cyndi Sue Dassinger, Angela Cowden, Rob Livingston, and Gil Riordan.
- 3. Invocation: By Heather Beato.
- 4. Approval of Minutes Minutes for the meeting on June 3, 2022, were approved by email.
- 5. President's Report: Josh Stewart reported:
 - a. <u>Bank Accounts</u> Opening of new bank accounts with MidFlorida Credit Union is almost completed.
 - b. <u>GroupMe App</u> Requested board and members to download this application to facilitate club communications.
 - c. <u>Club Business Meetings</u> Josh Stewart will use the first meeting of the month as a business meeting to update members on issues discussed at board meetings and other matters that members should be informed about.
 - d. Online Auction Provided the concept of the fundraising event scheduled for November 2022. Also, clarified that there will be no Apple Sale in 2022.
 - e. Board Meetings -
 - (1) Josh said that he received comments from board members with their concerns about the current alternating schedule for board meetings and suggested that a change was needed.

- (2) Heather Beato moved, seconded by Liz Fischer, to schedule all future board meetings on the 1st Tuesday of the month, 12 noon, at Dimitris. Seven board members present voted to approve motion.
- (3) One board member voted to approve motion by email. One board member voted against the motion. Motion passed by majority vote.
- f. Freedom Flight Josh Stewart reported that three guardians are confirmed for the upcoming trip and that one vet is confirmed. The club budgeted for five vets. Josh Stewart said that the \$6,250 payment is due, and that he would pay it from Sunrise Foundation checking account to meet deadline.
- 6. <u>Immediate Past President / Vice President</u>: Heather Beato reported on the allocation of DDF Funds:
 - a. \$1,000 were sent for the Cleft/Palate Global Project. \$1,200 were approved for that project.
 - b. There were \$825 balance that had not been designated, plus the extra \$200 not sent.
 - c. The two Honduras projects are not active; the Haiti project, HANWASH, is active (to her understanding) but some individual members had expressed reluctance on sending money to Haiti due to accountability issues. Although it was stated at the presentation, we heard that there are safeguards to prevent that with HANWASH, concerns remain.
 - d. No decision was made on the balance.
- 7. President Elect: Brian Kampman, not present.
- 8. <u>Secretary</u>: <u>Carlos Román</u> Reported that RI had transferred Sunrise Club members to the Rotary Club of Sebring. DACdb consolidation was pending.
- 9. Treasurer Bruce Lybarger
 - a. Debbie Cwalinski reminded the Board of the Smile Amazon program which donates a percentage of purchases to Rotary.
 - b. Discussion aroused about the increase in the lunch/breakfast cost and that there were concerns about the value of the meal being provided. Liz provided some observations about other potential venues but none of them provided lunch or had kitchens to support a caterer.
 - c. Josh Stewart provided copies of bank reconciliations for old Sunrise club accounts for June 2022. See copies at Enclosures 1 and 2.
- 10. <u>Sergeant-at-arms</u> Rob Livingston, not present.
- 11. <u>Fund Raising</u> Liz Fischer, no report. Josh Stewart added the Online Auction in November 2020 and the Golf Tournament in May 2023.
