COMMUNITY ALLOCATION'S PROGRAM REQUEST FOR FUNDING PROPOSAL APPLICATION

The purpose of the Rotary Club of Dougherty County's Community Allocation's Program is to provide financial support to non-profit organizations that adhere to the Rotary Four Way Test and further support one or more of Rotary's Six Areas of Focus: Promoting Peace, Fighting Disease, Providing Clean Water, Saving Mothers and Children, Supporting Education and Growing Local Economies.

The Four Way Test:

1. Is it the **TRUTH**?
2. Is it **FAIR** to all concerned?
3. Will it build **GOODWILL** and **BETTER FRIENDSHIPS**?
4. Will it be **BENEFICIAL** to all concerned?

Applications will be evaluated using the following criteria:

- How well does the proposal address one of Rotary's Six Areas of Focus?
- How well does the project fit into the organization's strategic plan?
- How well will those served and the community benefit from this program?
- Is the project adequately designed for success (human capital: staff, Board, volunteers)?
- What resources does the organization bring to the proposed project (funding, equipment, etc.)?

Each application packet should include:

- Proposal application (this document)
- List of current Board of Directors (1 page)
- Copy of your 501(c)(3) determination letter

Applications must be received on or before midnight August 1, 2015. **Late applications will not be considered.**
