Prof. Dr. Ariella (Ariel) Rosita King founded The Ariel Foundation International (AFI) (www.arielfoundation.org) in 2002 as a non-profit organization with an international focus on children and youth inspired leadership and participation worldwide. Skilled in International Affairs, Diplomatic protocol, Non-profit Organizations, and participation in International Multilateral organizations (United Nations, European Parliament, African Union, National Parliaments). Strong diplomacy, international consultancy, and strategic business development she founded (<https://www.drkingsolutions.com>) in 2022, a development Ariel Consulting International, a company since 1998 that creates and enhances Public-Private Partnerships, policy, and management. Concerned Dr. King founded the Ariana-Leilani Children’s Foundation International in 2008 to educate and advocate for Children’s Human Rights through the United Nations Convention on the Rights of the Child (UNCRC) that is signed by every country in the world, but only not ratified in one country.

Dr. Ariel King is a Rotarian in various countries and clubs for over 30 years. Dr. King is the Ariel Foundation International Representative at the European Parliament in Brussels and Strasbourg. She is also the Main Representative at the United Nations in New York, Geneva, and Vienna for AFI with Special Economic, Cultural and Social Council Special (ECOSOC) status. Since 2000 Dr King has also represented and assisted various delegations and NGOs to understand and engage in meeting by the United Nations in Geneva (UNOG), the United Nations in Vienna (UNOV) and United Nations in New York. In later years she has also worked with the United Nations in Kenya (UNEP) and in Rome (FAO).

Dr. King’s life focus is on inspiring leadership and participation of worlds’ children and youth. Ariel Foundation International is a member of EuroChild, Dr. King is the editor of Kid Changemakers Magazine, editor of Court Magazine. Dr King is on the Advisory Board of Global Leaders Magazine and the Vice President of African Orphans Education Foundation (AOEF). Dr King was a Trustee for Children’s Rights Alliance England (CRAE), Now Just for Law Kids, and the Acid Survivors Trust International (ASTI) United Kingdom.

Dr. King is the Founder and Editor-in-Chief of Kids Changemakers Magazine, the Editor of Court Magazine, and an International Advisory Board member for Global Leadership Today Magazine (GLTM). Dr King is a Board member of African Union Watch (AUW), the Vice President of the Board of Directors for The African Orphan Educational Foundation (AOEF), an Election Committee Member for Eurochild, and a visionary for programmes for the World Humanitarian, including the inception of it "Youth Committee."

Dr. King is the Editor in Chief for the Ariana-Leilani Children's Foundation that publishes the Ariel Foundation International's child and youth written publications, with over 64 in the last 10 years on www.Issuu.com/ArielFoundation in various languages (English, Spanish, French, Chinese, Arabic, Lithuanian, KiSwahili, Urdu, Twi, Turkish, and more) by Children and youth who participated in meetings and summits at or with the International United Nations, European Parliament, UK Parliament and Senegalese Parliament.

Health Management (MIM) from Thunderbird School of Global Management; Master in Public Health (MPH) in international Health from the University of Texas School of Public Health; and a Bachelor of Arts (BA) from the University of Hawaii at Manoa.

Dr. King is currently completing a master's in law degree (LLM) at University of London in International Human Rights Law, with a focus on Children and Youth. She also has completed advance certificates in the study of Children's Human Rights, from the UER Droits de l'enfant/Children's Rights Unit, Institut Universitaire Kurt Bösch (IUKB) in Switzerland, Certificate MIKK International Mediation and Cross Family Boarder Mediation.

Dr King is a worldwide speaker, presenter and trainer who has travelled to over 75 countries, has lived in 12 countries, and speaks four languages (English, French, Spanish and German), and has learned to read Hebrew.
