CORPORATE MEMBERSHIP APPLICATION

Corporate Memberships start with a regular full-time, full-fledged member (Corporate Active) at \$900/year (\$225/quarter), plus a highly encouraged donation of \$200/year (\$100 for the Rotary Foundation and \$100 for the Georgia Rotary Student Program). Corporate Active members have all rights and privileges of a Rotarian such as being elected as Officers or Board Members.

Additional members (Corporate Associates) can join under the corporate structure at \$500/year (\$125/quarter) each. Corporate Associates are local members and not full Rotarian members under Rotary International (RI). This contribution covers meals and other local expenses. Additional members (Corporate Associates) are limited to 3, for a total of 4 members per Corporate Membership. Any and all members of Corporate Membership are encouraged to join committees or be a Committee Chair.

In exchange for the lesser rate for local member additions, Corporate Members agree to host one event/meeting per year for every two members represented. This includes cost of space, meal, or this could be done as a Vocational Visit. For example, if the Corporate Member Company had 3 members, that group would host one event—perhaps a lunch meeting or social event. If the Corporate Membership is increased to four members, the organization will do a second event.
