With support from the Sunrise Rotary Scholarship, I was able to pour my time and energy into extracurricular research at the University of Central Florida. In that time, I traveled widely to collect samples. I got to visit places like the American Southwest, Central China, and all over the state of Florida. I completed several studies on wildlife genetics that are now published and became qualified enough to enter directly into a competitive Ph.D. program after graduating. I'm now in the third year of my doctorate at the University of Toronto. This May I will head to China for six months to work closely with my collaborators there on an invasive species study. With luck, I hope to land a job in the USDA (US Department of Agriculture), USFWS (US Fish and Wildlife Service), or USGS (United States Geological Survey) after I graduate with my doctorate.

Dear Applicant:
