Sheriff Comes To Town!

Martin County Sheriff Bill Snyder was our speaker today. The Sheriff has over 30 years of law enforcement experience and brings a lot of knowledge to his present job. He also served 6 years as a state legislator where he chaired the Judiciary Committee.

In response to some questions from club members the Sheriff outlined some of his concerns with Amendment 2 to legalize the use of Marijuana.

Sheriff Snyder pointed out that the amendment had been drafted by a Tampa law firm and has some major flaws as the sheriff sees it. As a constitutional amendment it is not subject to any legislative hearings or discussions, but if passed, would become a permanent part of our state constitution. This is a major difference from a Statute that would be subject to public hearings and the review and approval of the state legislature and other state government bodies.

The language allows a doctor to recommend the drug for "any other illness" including undefined "pain". It lacks any medical guidance or limits for the products.

A "Caregiver" can be certified to pick up drugs for a patient. The requirement to be a caregiver is to be at least 21 years old.

The doctors would give the patients "certificates" to pick up the drugs at a marijuana dispensary. They are not given "prescriptions".

The amendment also removes the doctors, patients and dispensary owners and employees of any liability in the use of the drug and the resulting civil or criminal acts committed by the patient.

This approach to lawmaking is a dangerous approach to a very serious process of providing help to patients in need. It deserves a much more open and transparent path to law making to assure that we are not creating another "pill mill" experience for Florida.
