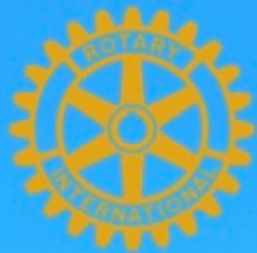
Mark enjoys swimming, biking, running, hiking and spending time with family.

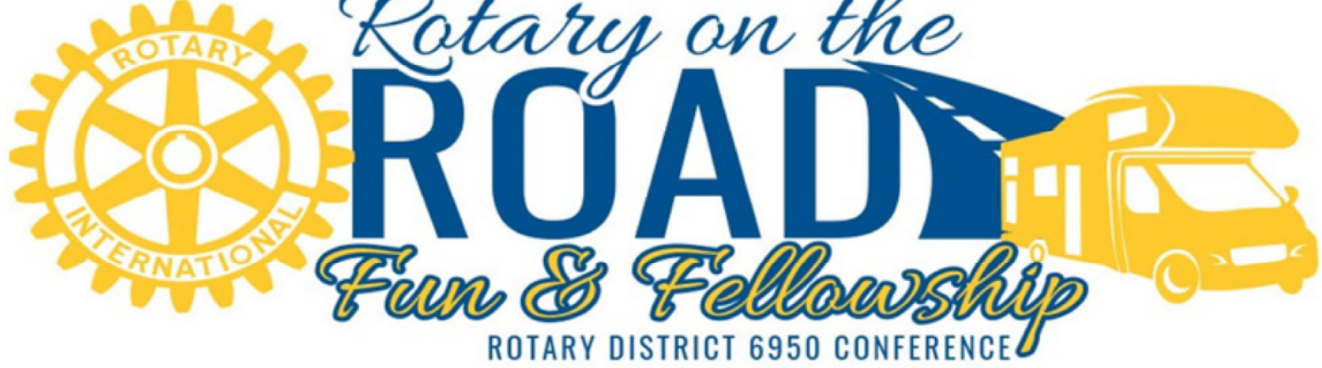
