Committee	Description
Administration	This Committee assists the Club with the logistical tasks that help make the Club meetings successful.
By-Laws	This Committee reviews, advises, and updates the Club's by-laws to reflect current practices, as directed by the Board.
Charity	This Committee reviews financial solicitations submitted to the Club and recommends a course of action to the Board of Directors. They also distribute funds as directed by the Board.
Citation	This Committee assists the Club by monitoring the Club activities toward achieving RI goals and providing incentives and motivation.
Club Socials	The Club Social Committee is responsible for creating monthly opportunities to build camaraderie.
Community Service	This Committee is the community engagement arm of the Club. It connects us to the Community through various projects. Our Flagship Service Project is the Northwest Legends Elementary School.
Compliance	The Compliance Committee is responsible for monitoring and resolving any organizational risk.
Event Planning	The planning committee is responsible for the event's overall planning, including everything from budget to the venue, guest list, to guest RSVPs (responses). They also ensure their volunteers know how to conduct a successful event.
Finance	The Finance Committee prepares and monitors the Club's annual budget.
Foundation	The Foundation Committee ensures that the Club is educated and encouraged to support the International Rotary Foundation Program.
Hospitality	This Committee is responsible for creating a welcoming environment for all participants.
Membership	This Committee ensures the completion of the onboarding process for New Members while preparing them to serve as Rotarians. They also recommend courses of action to enhance the New Members' Experience with the Board.
Policy & Procedural	This Committee reviews and recommends standard operating procedures in the interim of By-Law reviews.
Program	This Committee secures guest speakers and district lecturers for the Club's monthly meeting.
Public Image	This Committee ensures that the Club conforms to Rotary International standards while promoting the Club to the Community through various social media platforms.
