First employed as a fledgling journalist, George went on to serve Her Majesty's Government, in the smuggling and drug enforcement department. After moving to England, George started his own company - George Hotels Ltd, and specialized in ownership and operation of Hotels, Restaurants and English pubs. George sold all of his UK business interests and moved to the United States in 2004 with his wife Carole and daughter Pippa.

George started GRB Properties LLC in Florida, but retired in 2008 when he secured green card residency, George, Carole and Pippa became US citizens in 2015. A Past President of the Bartow Rotary Club, and Past District Governor of District 6890, George is currently serving his second three year term as District Representative to the Council on Legislation.
