- No part of the grant shall be used for the principal purpose of carrying on a trade or business for profit.
- No part of the grant shall be used for carrying propaganda, or attempting to influence legislation, or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.
- The applicant agrees that grant funds shall be utilized solely for the purposes set forth herein, adequate safeguards will be implemented to ensure same, and recipient will cooperate in any inspections or audits to ensure same.
- Accountings of the uses of such funds and adequate records thereof will be provided as requested.
