In addition, the club runs one or two annual fund raisers to support our local charitable initiatives. Each member is expected to sell or buy tickets to these events. We have one major fundraiser which generally has a requirement to sell 6 tickets @ \$75 to \$85 dollars each.

All of these monies go to support our charitable causes which include:

- 4 annual scholarships of \$1,000 to deserving local students
- Donations of \$500 to \$1000 to a number of local organizations

Other activities we perform: Adopt a road quarterly, Meals on Wheels deliveries, helping local residents with yard clean-up, etc

We also have internal committees which every member can bring a specific area of expertise and participate in. These committees are what keep the clubs initiatives in gear. They include our Social Committee, Youth Services, Membership, Public Relations, Scholarship and Grants Committees.

We realize not all members can participate in everything but our expectation is you will support our causes, help physically where able, and join one of our committees as well as have FUN!!
