Emily Fetcko, the new CEO of the Erie Downtown Partnership, will be our speaker for this meeting.

Learn about the importance of public space in a post-pandemic world and how we can reimagine public space for a new generation of residents, visitors, and businesses. We'll discuss how public space impacts both economic vibrancy and quality of life. And we'll explore ways public spaces in downtown are being considered for transformation.

Emily has 20 years of community and economic development experience and works across the community to marry opportunity with resources, writing grants that have contributed \$1.6 million toward downtown revitalization in Erie. She has led downtown public art projects that included collaborations with refugees, English as a Second Language students, minority artists, and educators. She

was named CEO of the Erie Downtown Partnership last summer and works with a small group of equally passionate and energetic team members to put the downtown partnership's mission into action. She also represents the region as a board member and Vice Chair of the Pennsylvania Downtown Center.

Jim Hynes

Jim is a native of Oil City, graduating from Oil City Senior High School in 1971. He continued his education at Gannon University, graduating with a BS in Accounting in 1975. Jim passed his CPA exam in 1976 and continued his professional education for over 30 years as required to maintain an active CPA license. Jim is a Past President of the Erie Chapter CPAs and received Life Membership status in the Pa Institute of CPAs after 40 years of membership.

In addition to receiving his BS degree at Gannon Jim was also commissioned a 2nd Lieutenant in the US Army, Air

Defense Artillery. Jim remained active in the US Army Reserves attaining the rank of Captain before honorable discharge in 1982.

Jim began his professional career at Ernst & Young where he was promoted through several levels to Senior Tax Manager. He then joined Zurn Industries as Assistant Treasurer / Manager of Taxes when Zurn was a Fortune 500 company headquartered in Erie (his favorite position). Jim also held senior financial positions with IHDG /Blackstone, Bliley Technologies, Rentway, and Swanson-Erie before his retirement in 2022.

Jim has been active in numerous service organizations over the years including the Erie
Chapter CPAs, NW PA Financial Executives, Catholic Charities, Gannon Financial Advisory Council, United Way,
Perseus House, New Ventures, Kearsarge Rotary and Erie Rotary.

Jim resides with his wife Jane in Fairview. His daughter Julia resides in Brooklyn, NY and his son Jim and daughter Jillian reside in Erie.

Linda Moore

Linda Moore was hired at the Sight Center of Northwest PA in 1999 and became its CEO in February 2009. She likens the early years of her job as CEO to "turning the Titanic on a dime": a job that included a capital campaign to move the agency to a new location, as well as changing the agency name, the leadership, the mentality, and the business model of one of Erie's oldest social service agencies, all while maintaining the mission and the extraordinary quality of service that were its hallmarks. She learned the ropes from her friend and mentor, Tyco Swick, the agency's executive director for 46 years who continues to contribute to the agency as its Lions Clubs Liaison and Eye Care Coordinator.



Linda strives to raise the quality and effectiveness of the programming at the Sight Center, including seeking and achieving accreditation from the PA Association for Nonprofit Organization (PANO) for adherence to the Standards of Excellence in Nonprofit Ethics and Accountability. One of the primary focuses of Linda's job today, as it is with most nonprofit executive directors, is the sustainability of its programs into the future.

A native of Rochester, NY, Linda holds a bachelor's degree in business administration from the University of Alaska at Anchorage, where she also worked full-time for three years for the senior vice chancellor. Returning to Rochester, she was part of the development team at the International Museum of Photography at

George Eastman House during its successful \$12.6 million capital campaign. She was assistant director of the Rochester General Hospital Foundation for three years during which she successfully led its annual and capital campaigns.

Linda and her husband, Kevin Moore, have a boisterous blended family of 5 children ages 21-31 and a beautiful little mixed breed dog named Olivia Rose.


