Dr. Gregory Filbeck PSU Black School of Business



Greg Filbeck holds the Samuel P. Black III Professor of Finance and Risk Management at Penn State Behrend and serves as Director of the Black School of Business. Before joining the Faculty at Penn State Erie in 2006, he served as Senior Vice President of Kaplan Schweser from 1999 to 2006 where he was in charge of all content and curriculum. He also held academic appointments at Miami University (Ohio) and the University of Toledo, where he also served as the Associate Director of the Center for Family Business.

Professor Filbeck has authored or edited nine books and published more than 90

refereed academic journal articles appearing in the Financial Analysts Journal, Financial Review, and Journal of Business, Finance, and Accounting among others. He serves on the editorial board of the Journal of Business and Economic Perspective.

He conducts consulting and training world-wide for candidates for the Chartered Financial Analyst (CFA), Financial Risk Manager (FRM™), and Chartered Alternative Investment Adviser (CAIA®) designations. He holds all three designations along with the Professional Risk Manager (PRM™) designation. He has conducted training for Goldman Sachs and the New York Society of Financial Analysts as well as numerous public, online, and video-based programs. He currently serves as President of the Southern Finance Association and the CFA Society Pittsburgh and was the President of the CFA Society Toledo from 1998 to 1999.

Professor Filbeck received The Impact on Practice Award (2015) and Outstanding Scholar (2016) from the Black School of Business, the outstanding teaching award among iMBA faculty in 2010 and 2012, the Penn State Behrend Regents award for Outstanding Researcher in 2011, and was the 2013 recipient of the Penn State Behrend Outstanding Outreach Award. He has a BS (engineering physics) from Murray State University; a MS in Applied Statistics from Penn State University and a DBA (finance) from the University of Kentucky. Besides his work in finance, Professor Filbeck is a Professionally Registered Parliamentarian, is a qualified administrator of the Myers-Briggs Type Indicator, and has 12 years of experience in radio broadcasting. He holds leadership roles in numerous community organizations including serving as President of the CFA Society Pittsburgh and Past-President of the Southern Finance Association.



HOWARD LINCOLN

Born into this world on June 28, 1938 Left this earthly classroom on October 23, 2017

"Howard Lincoln, an old time member of the Club, passed away on Monday. He visited the club at our meetings when he was spending time in Erie. In retirement he lived in Boca Raton, Florida. When he was living in Erie, he gave his time and energy to many Erie community organizations." - Gary Flick

Howard Conrad Lincoln, age 79, of Erie, passed away peacefully on Monday, October 23, 2017, surrounded by his wife and family. Howard was born June 28, 1938 in Erie, PA to Nina Soloway Lincoln and Barney Lincoln. A graduate of Academy High School, Howard participated in many sports including football and swimming, and followed in his father's footsteps as a Presque Isle State Park Lifeguard. He received a bachelor of science from Penn State University, where he was a member of Phi Epsilon Pi fraternity and business manager of FROTH, the humor magazine. A beloved teacher and gifted coach, he taught physical education and served as Head Coach of the swim team at Newark Academy in Livingston, New Jersey for six years, and was later inducted into their hall of fame for developing an East-coast powerhouse team of swimmers and divers, which boasted seven high school All-Americans on a single team.

Howard and Mary married and moved to Erie in 1967. Howard joined his father in building Lincoln Metal Processing, now Lincoln Recycling, with operations in Erie and Meadville. He founded Computer Recycling of America in the late 1970's to capitalize on soaring gold prices by recovering precious metals from computer assets. He co-founded Lincoln Foundry, Portable Baling Services, and Wild Waves skateboard park, a pioneering youth activity park. In pursuit of scrap metal opportunities, he traveled to the Afghanistan and Pakistan, and had the honor of meeting with the then-President of Pakistan. While not all ventures led to new business, they did provide many entertaining stories for which he was well known.

Howard generously gave his energy and resources throughout the Erie community. He served as President of the Erie Philharmonic, and supported many organizations, such as The Flagship Niagara League, Erie County Library System, Hamot Health Foundation, Americans for the Competitive Enterprise System (ACES), Asbury Woods, Inner-City Neighborhood Art House, Erie Playhouse, and Erie Philharmonic. He was a member of civic organizations including Sertoma, Y-Mens Club, Masonic Temple and the Rotary Club of Erie. Always a supporter of youth, education and arts, in 2009 he spearheaded the founding of the Young People's Chorus of Erie in collaboration with Penn State Behrend, which has served over 1000 students to date in Erie and Crawford counties in choral education, performance and fellowship. In retirement, Howard served as President of the condominium association of Boca Towers in Boca Raton, Florida.

In addition to his parents, he is preceded by his son, Stuart Michael Lincoln and a brother-in-law, Irwin Rider.

Howard is survived by Mary Swed Lincoln, his wife of 50 years; a daughter Samantha Lincoln, her husband Scott Gezymalla and their daughters Marin and Eva Gezymalla; son Jeremy Lincoln, his wife Elizabeth Dwyer Lincoln and grandsons Findley and Taylor Lincoln; and son Andrew Lincoln, his wife Amanda Schantz Lincoln, and their daughters Avery and Elise Lincoln, all of Erie, PA. He is also survived by his sister Laurel Rider, niece Cathy Rider Woldanski (Stan Woldanski) all of Richmond, VA; cousins Douglas Klein (Carolyn Klein) of Erie, PA; Michael Klein (Marcy Klein) of Bloomfield Hills, MI; and Cynthia Klein of Montecito, CA.; and several nieces and nephews.
