
1. President and President Elect Matters

- Received sponsorship requests from MHY and IH2 were discussed at meeting. MHY was tabled until they respond to Dave's e-mail requesting a meeting and the Board agreed to \$500 for the May 4 IH2 event.



- Dave updated on the Golf Outing Fundraiser: Dan and Ken are working with Butler CC to nail down a few items and we should then be ready to sign the contract and get the registration open. Dan will be contacting Sally and getting them on board. Ken did reach out to NexTier and before they commit, they would like more information on the sponsorships available, which we will have ready when we complete all of above.


- May 4 help Satellite at Shred-It Event
