ELECTION OF THE DISTRICT'S REPRESENTATIVE AND ALTERNATE REPRESENTATIVE TO
THE RI COUNCIL ON LEGISLATION FOR THE ELECTION OF THE DISTRICT GOVERNOR
NOMINEE. ALL VOTES FROM A MEMBER WITH MORE THAN 1 VOTE SHALL BE CAST FOR
