About the Huntingdon Community Center:

Our vision is to enrich the quality of life for our children, families, and communities. Our mission is to provide structured educational, recreational, and social programing in a safe and inclusive environment. We value community, support, innovation, commitment, mentoring, enjoyment, and character. Our goal is to give children a place to be themselves, as bright, happy and motivated as possible.

The Huntingdon Community Center is located in a very rural central Pennsylvania approximately 30 miles South of State College Pa and 30 miles East of Altoona Pennsylvania. Huntingdon County's 2018 population (estimated) showed approximately 45,168 populous with the most significant concentration of population in the County seat of Huntingdon (pop ~8,000).

The Huntingdon Community Center, located in the Borough of Huntingdon, is operated for the purpose and object of establishing and maintaining a Center for the social enjoyment and recreation to primarily benefit the youth of the Borough of Huntingdon, Pennsylvania, and surrounding communities. No person is omitted from being able to participate in any activities of the Centers due to their inability to pay for activities to which there is a charge, such person shall be on 'scholarship' and services will be free.

For over 60 years, the non-profit Huntingdon Community Center, (HCC, 501 c.3.), has been a fixture in the Borough of Huntingdon and Huntingdon County. HCC has provided activities and athletic programming to a population of children ranging in age from preschool to young adult. The HCC provides a supervised safe haven for young people, away from the influences of drugs, alcohol and tobacco. In 2019, HCC provided services to over 2,500 children through various wholesome programs such as track and field, soccer, tee ball, basketball, and gymnastics. Additionally many children have used the Center's supervised game room facilities, effectively providing them with alternatives to roaming the streets. The HCC promotes these activities at three locations, 5<sup>th</sup> and Mifflin; William Smith; and Detwiler Field. Additionally, the Center offers weekend programming and after school programs designed to provide children activities in a supervised environments. The HCC sustains itself on an annual operating budget of approximately \$200,000. Most of these funds are obtained through community generosity, fund-raisers and registration fees. Staffing includes one full time paid director and other seasonal and part time personnel as needed. A non-paid board of directors oversees HCC operations and hundreds of volunteers serve as coaches and tutors.

#### Our Need:

Among our many needs, the Heating, Ventilation and Air Conditioning system (HVAC) at our 5<sup>th</sup> Street facility has reached the end of its' operational life. #### Option 1

- Daikin single zone condensing unit mounted on the wall on the Washington St side
- Daikin 18,000 wall mounted unit in the 1<sup>st</sup> floor room
- Line set in white slim duct
- Labor

The total to install this unit is \$3,450.00

#### Option 2

- Daikin multi zone condensing unit mounted on the wall on the Washington St side
- Daikin 18,000 wall mounted unit in the 1st floor room
- Daikin 9,000 btu wall mounted unit in the 2<sup>nd</sup> floor office
- Run new line set with white slimduct
- 2<sup>nd</sup> floor line set will go down exterior side of the building back in above the ceiling tile to the other side to connect to the condensing unit
- 2<sup>nd</sup> floor unit will drain to the drain on the exterior drain on the Mifflin St side
- Labor

The total for this unit is \$6,850.00

Subpanel electrical work shall be done by electrical contractor.
