- 1. Briefly describe the proposed project. What will be done, when and where will the project take place, and how many people will benefit from the project? How will the project benefit the community?

  The Morgan County Homeless Coalition recently leased a building in downtown Berkeley Springs and is renovating the space for a year-round homeless shelter. The anticipated opening date of the new 10-bed shelter is December 2022. The Berkeley Springs Rotary Club plans to purchase some furniture for the new shelter. This facility will provide a safe and comfortable temporary space for the local homeless population. In 2021, Morgan County Homeless Coalition volunteers staffed temporary housing during the winter months (December 1- March 1) and had 839 "bed nights". With the new shelter being a year-round facility, the number of "bed nights" is expected to increase significantly.
  - 2. How many club members will participate in the project and in what role? Is there a cooperating organization also involved and what will their role be?

Two Berkeley Springs Rotary Club members will work with the Morgan County Homeless Coalition to determine what furniture is needed for the shelter and then purchase the furniture. Another two to four rotary club members will deliver and set-up the furniture at the homeless shelter. Other club members will participate in the fundraising efforts for the project.

3. Will the project be completed if less than requested funds are granted?

If yes, will the project be modified if this occurs, and if so, how?

Yes, the project will be completed if less funding is received. If less funding is received, the project will be modified by reducing the amount of furniture that is purchased for the new homeless shelter.

4. How does this project reflect the mission of The Rotary Foundation?

The project aligns with The Rotary Foundation's mission to advance understanding and goodwill by improving the health of the local homeless population as well as improving the environment for them. The furniture provided by the Berkeley Springs Rotary Club will assist the Morgan County Homeless Coalition in providing a safe, comfortable, and welcoming environment at the homeless shelter.

Clubs must have entered a (non-zero) Annual Fund Goal and at least 13 goals for the 2022-23 Rotary year in MyRotary by August 1, 2022

Club must be current on Rotary International and District Dues.
