Speaker: Trevor Walter, how gasoline is transferred across the country Trevor has been employed by Sheetz for 12 years and is the VP of Petroleum Management. He is a Penn State Alum. Trevor gave an overview of the key players in the Fuel Management department. Last year sold 2.5 billion gallons of gas.

Products move in grades thru the pipelines. Some mix occurs but managed by the terminal. Warren Pa refinery, pulls some crude oil from Canada. When fuel is purchased from the pipeline it is delivered into the terminal. Sheetz works with 69 terminals and each has different cost rates Sheetz works with six different pipelines. It takes 2-3 weeks for product to get from the Golf coast to Pennsylvania.

Staff build on the members' strength and give them the opportunity to try new things. Supported employment guarantees a member or

staff will work at an employment site. They seek out job opportunities on the bus route or downtown Referrals for the clubhouse can come from anyone

but must be signed off by a doctor. They are funded through Medicaid and county funding. The clubhouse has 25 active members and is open holidays for meals. They operate Mon thru Friday 7:30-3:30

The biggest benefit of the clubhouse is that it creates relationships and the clubhouse members become family.
