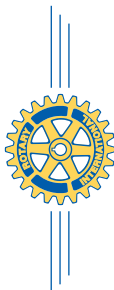

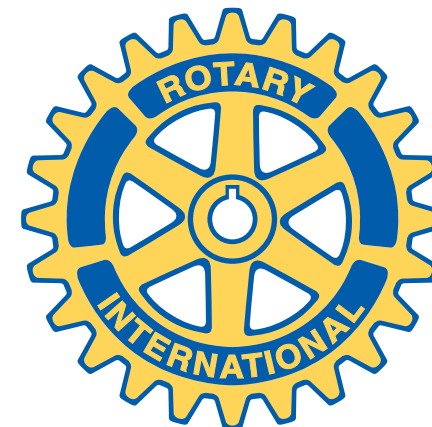

Program:

Commander Michael Howe, Naval Flight Officer and head of the NROTC Unit at Penn State shared with us. The NROTC has been in operation since 1926, starting with six units and now operating 63 units. A 64th unit will be opening in Hawaii next year. NROTC offers full scholarships (minus room and board) for 650 national scholars. These are 2-4 year scholarships. Commander Howe shared challenges and responses to them through changes in training for students. The units produce "war fighters", through stripped down boot camps, sea trials and specialized training. They produce 900 officers per year and have seen an increase in female candidates.
