

President Phil introduced our guest, Steve Sheetz by first sharing an early Sheetz hotdog commercial. Steve served as president of Sheetz beginning in 1981 and is currently the new Family Council Chairman.

Steve's topic; The Thrills & Challenges of Growing from one Store to 600, began with him sharing his employment with his brother Bob in 1960. Steve was one of eight children and his dad believed they should all start working the summer after turning twelve. Steve worked for his Brother Mon-Fri, 8-1 and earned \$20 per week. The store had ten employees and five of them were siblings. Today, Sheetz has 21,000 employees, earns \$7.5 billion annually and serves 1.5 million customers per day. This year the Sheetz stores took 1010 of their store managers to Disney in Orlando. Steve shared philosophies that he lives by and his goal to have 1,000 stores. The next store will open in Columbus, Ohio. Steve answered questions from the audience.
