## **GUIDELINES FOR GRANT REQUESTS**

**Purpose:** Guidelines regarding "Grant Requests"

**Mission:** The mission of The Rotary Club of Prince George County Charitable Foundation

is to support the charitable activities directed to the well being of the residents of

Prince George County, Virginia and the surrounding areas, as well as

international projects meeting Rotary Foundation criteria

**Policy:** Grant requests will be reviewed at least once quarterly. However, an organization can receive no more than one grant per Rotary year.

 The organization must provide well-defined services and/or programs which are consistent with the mission of The Rotary Club of Prince George County Charitable Foundation or the Rotary Foundation.

- 2. The following entities may apply for a grant from The Rotary Club of Prince George County Charitable Foundation:
  - A. A community-based public or private non-profit organization with 501(c)(3) tax-exempt status and classified as a 509(a) non-private foundation, or if an international project, meets the Rotary Foundation criteria.
  - B. A tax-exempt operating foundation under 501(c)(3) and 4940(d)(2).
  - C. A government instrumentality or political subdivision.
  - D. Priority will be given to organizations or projects identified by the Rotary Club of Prince George County, but the applicant must submit the grant application and meet one of the eligible types of organizations listed in 2 A-D. The exception to that rule would be projects sanctioned by the Rotary Foundation.
  - E. The Rotary Club of Prince George County Charitable Foundation may also identify projects and provide funds for those grants on its own decision, provided the recipients are eligible under the IRS Code governing nonprofit entities.
- 3. The organization must submit a grant application which includes information regarding: (a) organization's mission; (b) services and/or programs provided by the organization; (c) utilization of contribution; (d) specific need the contribution will address; (e) effectiveness of this contribution; (f) target population to be served; (g) anticipated results and impact on the community; (h) a time frame of activities; (i) local leadership and community support for the project; (j) total amount requested and how much financial and in-kind support can be obtained from other sources; and (k) list contact person, name of organization, address and phone number.
- 4. The organization receiving a grant must provide a summary within three months after receiving the grant, which addresses the following: the extent to which the organization has met its objectives; demonstration of community commitment and support for the organization/project and how the organization delivered services and programs.
