This message is to inform you that the Program' current liability policies will expire 1 July 2020 12:01 a.m. New insurance policies will be purchased to provide continuous coverage and we will make every effort to provide the same broad coverage as per the expiring policy. To facilitate your budgeting process, we will provide renewal premium/rate information to you in June.

We are experiencing the most challenging insurance market in over 15 years - Insurance companies are raising insurance premiums at unprecedented rates due to increased litigation and high awards in court verdicts. We expect that these increases will also affect the Program and your insurance assessments. We will make every effort to minimize these increases.
