The concern is potential legal ramifications to our Club should there be any problems in the future from the new owner. The Board agreed to investigate a little further (Dana to speak to Mike Holleran) as to whether our Club should pursue this as a fund raising mechanism. For the record there were 3 Board Members voting to abandon this issue now (Bob Rosenbaum, Bob Jansen and Carol Stone).

McLean Rotary Foundation Report: We mentioned this and noted this report denotes where all our fund raising efforts go. This is the same report the Foundation Chair John McEvilly distributed to the entire Club.

Club's 50th Anniversary: Michael A. reported that we are doing very well in terms of number of Club members attending (somewhere in the 80-85% range). Michael will be emailing the former Presidents. He has a list of former members but we don't believe that list is all inclusive. The idea was suggested and well received to contact the Falls Church and Tysons Clubs. Falls Church helped found our Club and we helped start the Tyson's Club.

Upcoming Events: We noted the upcoming *Monte Carlo Night* (November 6th) and noted Glenn has recently distributed the latest meeting minutes for the Committee organizing that event.
